State Experiences Designing and Implementing Medicaid Delivery System Reform Incentive Payment (DSRIP) Pools

Several states are operating DSRIP programs through their Medicaid programs under the authority of Section 1115 demonstrations. These programs incentivize system transformation and quality improvements in hospitals and other providers serving high volumes of low-income patients.

[This report](#), prepared by NASHP staff, for the Medicaid and CHIP Payment and Access Commission (MACPAC), provides an in-depth analysis of eight current DSRIP (and DSRIP-like) programs in addition to federal, state, and provider perspectives on program implementation. It also offers insight into the role of DSRIPs in the Medicaid delivery system by examining key policy issues including program design, financing, measurement, and monitoring.
