Dear Mr. Keck,

As the contractor for the Jurisdiction C Durable Medical Equipment Medicare Administrative Contract (DME MAC), we are advising you of the fee schedule changes that will be made based on the October Quarterly Update for 2014 Durable Medical Equipment, Prosthetics, Orthotics and Supplies (DMEPOS) Fee Schedule. These changes will be implemented per Change Request (CR) 8865 from the Centers for Medicare & Medicaid Services.

Effective October 1, 2014, the following two new codes have been added to the HCPCS file:

- K0901 - Knee orthosis (KO), single upright, thigh and calf, with adjustable flexion and extension joint (unicentric or polycentric), medial-lateral and rotation control, with or without varus/valgus adjustment, prefabricated, off-the-shelf
- K0902 - Knee orthosis (KO), double upright, thigh and calf, with adjustable flexion and extension joint (unicentric or polycentric), medial-lateral and rotation control, with or without varus/valgus adjustment, prefabricated, off-the-shelf

The October Quarterly Update for 2014 includes the fee schedule amounts for these two codes effective for dates of service on or after October 1, 2014. The following are the fee schedule amounts for the states in Jurisdiction C.
