Before we go off half-cocked we need to find out what is going on. Someone from the governor's office should have a good enough working relationship with the Comptroller to be able to get Nat Kaminski to tell you whatever he knows about the situation. If he doesn't know then the chances are this is either just a rumor or the problem is still "close hold" in the CIO office.

If Nat tells you it is just a rumor then you need to sit back and let it work itself out. If not then you need to get all the information you can from Nat and then based on that you (representing the Governor as Chair of the B&CB) need to ask Frank Fusco some very direct questions about this project. If they refuse then you need to get that refusal in writing.

Some questions that come to mind are:

What is the status of the project? Are you almost finished with Wave 1A? When does 1B start and who will be in that wave?

What is the status of Deloitte? Are they still working on this project? If they are, get a daily total of the number of personnel physically on the job and billing each day for the past 30 days. Do they have plans to stay on the job?

If they are not on the job: Why did they quit? What is the impact of that on the current project and the schedule? What is your plan to get the work they were contracted to do accomplished? Is there any plan to put the project on temporary hold until all of this can be sorted out?

Has the Oversight Committee had a report from their QA vendor? Are they planning to get one? Is all of this being held "close hold" by the CIO or is there a way to get to the bottom of this quickly.

You need to kind of feel your way into this to make certain you are not over-reacting and that if you begin to criticize you are on solid ground.

This just might be the "train wreck" I talked about four or five months ago.
