M I N U T E S

PRESENT: Chairman - C. Edward Poore

Mr. Poore called the meeting to order and Councilman David L. Hooper gave the invocation.

On the motion of Mr. Kinley, seconded by Mr. Wright, Council voted unanimously to approve the minutes from the November 3, 1981 meeting as mailed.

Mr. David Crenshaw explained that the Sheriff's Department was trying to raise money to purchase bullet proof vests for all deputies. He explained that they were in the process of selling some confiscated materials and he asked Council to amend their budget to include the funds from the sell to purchase the needed vest. On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to amend the budget for the Sheriff's Department. (1st Reading - Ordinance # 76)

Mr. Dick Thomas presented second reading of Ordinance #72 for transfer of Fort Hill Cable TV franchise to Video Properties, LTD. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to allow Video Properties the franchise.

Mr. David Hooper handed out samples of the proposed commemorative plaque for the Bailes Building. (See sample attached) Mr. Poore opposed having Pete Stathakis as the building consultant on the plaque. On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted 3 in favor and 2 opposed. Mr. Wright and Mr. Bratcher voted against the motion. Motion passed by majority vote.

Mr. Thad Arnold presented a request from the Solicitor asking that they put in book shelves in the new building for an additional \$2,040 in which the Solicitor has the money in his budget but would have to be transferred. On the motion of Mr. Bratcher, seconded by Mr. Kinley, Council voted unanimously to allow the transfer for the shelves. (Account #124)

On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to allow Mr. Thad Arnold to go ahead with plans on the renovation of the Courthouse.

Mr. Thomas, Veteran's Affairs Officer, explained a surplus in the salary account. He requested that \$500 be transferred to the telephone account and \$800 to rent. On the motion of Mr. Bratcher, seconded by Mr. Rhodes, Council voted unanimously to allow the transfer.

Mr. Don Garrison asked Council to approve \$20,000 of the income earmarked for Tri-County Technical College to be used on a parking lot project. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to earmark the needed money.

Mr. David Watson presented a request for the Anderson County Health Department to purchase malathion in the amount of \$5,500.00 from the State. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to allow the purchase.

Ms. Billie Coghlan asked Council once again for reimbursement for medical expenses incurred from a fall while serving on jury duty in September, 1980. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to direct the Supervisor and Purchasing Agent to review the budget for \$1144.00 to pay Ms. Coghlan.

On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to adjourn at 7:42 p.m.
