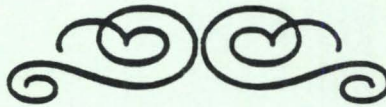

The regular monthly meeting of the Highways and Public Transportation Commission was held at the offices of the State Highways and Public Transportation Department in Columbia, South Carolina, at eleven o'clock a.m. on January 16, 1992. In compliance, with the "Freedom Information Act", the news media was advised in writing of the time, date and place of this meeting.

SECTION 1: The Honorable Jack E. Mullinax of Greenville, having qualified on January 16, 1992 as Commissioner for the Thirteenth Highway District, composed of Greenville and Pickens Counties, took his seat as a member of the Commission.

SECTION 2: The Minutes for the meeting of December 19, 1991; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 3: The Commission unanimously passed a motion approving monthly reports as published by the Department of activities for the month of December, 1991.

SECTION 4: The Commission unanimously passed a motion approving purchase orders issued for amounts in excess of \$10,000.00, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion authorizing the Department to increase the current contract with F&ME Consultants to provide Geotechnical Services (soil borings, lab testing, engineering analysis and design, field monitoring, recommendations, etc.) at an additional cost of \$250,000.00, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with Clemson University for Transportation Technology Transfer Service (T3S) for calendar year 1992, at an estimated cost of \$161,000.00, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion authorizing the Department to enter into supplemental agreement No. 10 with Stevens and Wilkinson, Inc., to provide construction engineering and testing services for the weight in motion stations in Dorchester and Spartanburg Counties at an estimated cost of \$215,000.00, as shown in the Appendix.

SECTION 8: The Commission unanimously passed a motion authorizing the Department to enter into supplemental agreement No. 3 with Ralph Whitehead & Associates to provide additional engineering for preparation of right of way and final plans for 14.3 mile section of S. C. Route 72 from S-64 to U. S. Route 221 at an estimated cost of \$1,619,000.00, as shown in the Appendix.

SECTION 9: The Commission unanimously passed a motion authorizing the Department to enter into supplemental agreement No. 1 with Florence and Hutcheson, Inc. to provide additional engineering for preliminary roadway and bridge plans and right of way plans for a 7.4 mile section of I-385 south of S. C. Route 101 to south of U. S. Route 221 at an estimated cost of \$693,000.00, as shown in the Appendix.

SECTION 10: The Commission unanimously passed a motion authorizing the Department to enter into supplemental agreement Nos. 4 & 5 with the LPA Group to provide additional engineering services for preliminary roadway and bridge plans, right of way plans and improvements to Fairview Road, Road S-543 (Old S. C. Route 418) and a section of I-385 from northwest of Road S-272 south of Road S-55 and a section of I-385 from south of Road S-55 to Laurens County Line excluding Fairview Road, Road S-543 (Old S. C. Route 418) at an estimated cost of \$1,311,000.00 for Agreement No. 4 and \$489,000.00 for Agreement No. 5, as shown in the Appendix.

SECTION 11: The Commission unanimously passed a motion authorizing the Department to provide technical assistance for bus service to S. C. State College, at an estimated cost of \$10,000.00, as shown in the Appendix.

SECTION 12: The Commission unanimously passed a motion amending the June 19, 1991 allocation of Public Transportation Funds, as shown in the Appendix.

SECTION 13: The Commission unanimously passed a motion approving the sale of surplus used motor vehicles and equipment located at the Department's Equipment Depot, Shop Road, Columbia, South Carolina, bids for which were received on December 18, 1991.

SECTION 14: The Commission unanimously passed a motion approving the sale of unserviceable junked and obsolete property located at the Department's Supply Depot, Shop Road, Columbia, South Carolina, bids for which were received on December 11, 1991, as shown in the Appendix.

SECTION 15: The Commission unanimously passed a motion authorizing the Department to advertise and receive bids for 8,135 SF right of way property in the City of Lake City, as shown in the Appendix.

SECTION 16: The Commission unanimously passed a motion accepting a report by the Department concerning the execution of a quitclaim deed dated November 26, 1991 conveying two parcels of land approximately 0.43 acre and 0.12 acre to Crest Investments, a Partnership for the consideration of \$5,635.00, as shown in the Appendix.

SECTION 17: The Commission unanimously passed a motion accepting a report by the Department concerning the execution of a quitclaim deed dated December 10, 1991 conveying approximately 0.13 acre of land, to Franklin Leon Cothran for the consideration of \$2,000.00, as shown in the Appendix.

SECTION 33: On motion of Commissioner Self, seconded by Commissioner Bailey, the Commission unanimously passed a motion authorizing the Department to request the SHIMS Oversight Committee to approve utilization of approximately \$22 million in SHIMS funds to match Federal funds.

SECTION 34: On motion of Commissioner Self, seconded by Commissioner Chapman, the Commission unanimously passed a motion to adopt revised estimated construction obligations for fiscal year 1991-92 to become effective immediately upon approval of the SHIMS Oversight Committee authorization to utilize \$22 million for State match.

SECTION 35: On motion of Commissioner Self, seconded by Commissioner Harvey, the Commission unanimously passed a motion funding the projected \$32 million shortfall in State match requirements for fiscal 1992-93 by recommending that the General Assembly increase user fees to generate approximately \$40 million. If the fee increase is not approved, then utilize 30% of "C" funds for resurfacing which will make available \$15 million and utilizing SHIMS funds for the balance of approximately \$17 million.

SECTION 36: On motion of Commissioner Harden, seconded by Commissioner Hamilton, the Commission unanimously passed a motion recommending to the Executive Director that the Mission Statement adopted by the Public Affairs and Publications Committee be used as the Mission Statement for the Public Affairs Department.

SECTION 37: On motion of Commissioner Alford, seconded by Commissioner Atkinson, the Commission unanimously passed a motion authorizing the Department to proceed with the implementation of an integrated accounting system with the Comptroller General to abolish the Department's lump-sum status.

SECTION 38: On motion of Commissioner Alford, seconded by Commissioner Hamilton, the Commission unanimously passed a motion requesting Mr. Marshall Reed of the Highway Users Federation to write a letter to the General Assembly stating his position on the size of the Commission and the size of the Highway Program.

SECTION 39: On motion of Commissioner Alford, Chairman of the Committee on the Future, seconded by Commissioner Harvey, the Commission passed the following motion. Commissioner Harden and Self cast negative votes on the motion.

The Commission advise the General Assembly that it recommends no change in the membership of the Commission at the time because

1. An eighteen member Commission is not excessive because the commission has and needs eleven active committee to deal with the various responsibilities of and divisions within the Department.

2. The responsibilities placed on the Commission by the General Assembly under the Secondary Road (C") Program requires close and constant communication on local roads by the Commissioners with the County legislative delegations and local governing bodies.

3. Based on recommendations of the Jorgensen Report and the Highway users Federation preliminary report the Commission is studying the size of the South Carolina Highway system and whether local roads should continue to be a State Highway responsibility and how the size of the system related to the membership of the Commission.

However, if the General Assembly concludes that the size of the Commission is an issue or that its composition should be based more nearly on population of the district represented, then the Commission recommends that the Commission be composed of two persons from each congressional district on staggered term to serve six year terms and would be elected by the Legislative Delegations from the Congressional district, that the member may not succeed himself on the Commission, that two members of the congressional district may be from the same county, and that the member being elected could not be from the same county as the person he is succeeding. The Governor shall appoint two members to serve during his term, one of which shall serve as Chairman.

SECTION 40: There being no further business to come before the Commission, the meeting was adjourned at 12:15 p.m.

AGREEMENT - F&ME CONSULTANTS

The Department entered into an open agreement with F&ME Consultants to be a Geotechnical Consultant, as requested, to perform Geotechnical Services (soil borings, lab testing, engineering analysis and design, field monitoring, recommendations, etc.), Pile Driving Analysis (PDA), and Environmental Services (particularly Underground Storage Tank Investigations.) The agreement was to run for 3 years or \$450,000.00, beginning January 1, 1990. The contract amount of \$450,000.00 was met in August, 1991. In October, 1991, the Commission authorized the Department to increase the agreement amount by \$240,000.00 in order to provide requested services for a few months, until a new agreement could be negotiated.

Because of heavy requests by the Department for PDA and Environmental Services beyond expected quantities on very urgent projects, the \$240,000.00 amount was exceeded by the end of December, 1991. Continued service, especially in PDA and Environmental is urgently needed, and it appears that it will be a few more months before new agreements for Geotechnical, PDA and Environmental Services will be in place.

Therefore it is recommended that the current contract with F&ME Consultants be increased by \$250,000.00 to handle the anticipated workload through April, 1992.

Mass Transit Service for S.C. State College

Mass transit (bus) service for S.C. State College and the City of Orangeburg is expected to begin during the second semester of FY 1992, under an "Entrepreneurial Services Challenge Grant Program" sponsored by the U.S. Department of Transportation, Urban Mass Transportation Administration (UMTA). The Department, in cooperation with UMTA, is responsible for administering this program through a project agreement with S.C.
