On August 26<sup>th</sup>, we will be hosting a webinar featuring Shawn Terrell, with the Administration for Community Living (ACL) at the U.S. Department of Health and Human Services. Mr. Terrell will discuss guidance and standards for person-centered planning that was released by ACL last month. This guidance has significant implications for Aging and Disability services, as ACL indicates that all Federal agencies with responsibility for HCBS should integrate the principles into their respective programs. According to ACL, the agencies most directly affected by this guidance include:

- Administration for Community Living
- Centers for Medicare & Medicaid Services
- Health Resources and Services Administration
- Indian Health Service
- Substance Abuse and Mental Health Services Administration
- Administration for Children and Families
