The regular monthly meeting of the Department of Transportation Commission was held at the North Myrtle Beach Municipal Complex at 4:00 p.m. on October 14, 1998. In compliance with the Freedom of Information Act, the new media was advised in writing on the time, date and place of this meeting.

SECTION 1: The Minutes for the meeting of September 17, 1998; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion authorizing the Department to forward to the South Carolina Budget and Control Board the Dorchester County "C" fund bond request in accordance with the following report:

**Report on Dorchester Bond Request**

The Dorchester County Transportation Committee (DCTC) has submitted a request to the South Carolina Department of Transportation for the issuance of \$2,000,000.00 in Bonds. These Bond Funds will be used to expedite the improvement of County and State maintained Roads in Dorchester County. The Bond Funds are to be repaid by the DCTC by setting aside enough of its annual C-fund allocation to repay the principal over the next 20 years.

The statute of law governing C-Funds is §12-28-2740. It provides that "*State highway bonds may be issued for the completion of projects for which "C" funds may be expended for projects as determined by the county transportation committee. The applicable source for payment of principal and interest on the bonds is the share of "C"*

*fund revenues available for use by the county transportation committee. The application for the bonds must be filed by the county transportation committee with the Commission of the Department of Transportation and the State Treasurer, which shall forward the application to the State Budget and Control Board. The Budget and Control Board shall consider the application in the same manner that it considers state highway bonds, mutatis mutandis."*

The projects to be constructed or improved are chosen based on a priority rating computed by point ratings in six categories. The categories are thoughtfully chosen and strive towards fairness. The priority rating system provides an objective means of selecting roads based on road condition and service to the public. The SCDOT has reviewed the proposed work on the roads on the state highway system and concurs with the roads selected and the scope of the work recommended.

The selection of State Roads was made by the Dorchester County Transportation Committee with input from local SCDOT personnel. The selection of County Roads for improvement was made by the Dorchester County Transportation Committee with input from County officials.

State Roads to be resurfaced, County Roads to be improved, and the Construction Schedule for Roads to be resurfaced in 1998 appear to have been fairly evaluated and selected.

SECTION 3: The Commission unanimously passed a motion accepting a report by the Department of surplus right of way property - land, as shown in detail in the Appendix.

SECTION 4: The Commission unanimously passed a motion accepting a report by the Department of surplus right of way property - buildings, as shown in detail in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the request of the Department to advertise, select and negotiate with consulting firms to provide engineering services for the preparation of right of way and construction for two segments of the new multilane Central Parkway project (RIDE plan) between 48<sup>th</sup> Avenue North and Harrelson Boulevard, as shown in detail in the Appendix.

SECTION 6: The Commission unanimously passed a motion approving the request of the Department to advertise, select and negotiate with consulting firms to provide engineering services for the preparation of construction plans for the US Route 501 Frontage Road project (RIDE plan) from the Intracoastal Waterway to Forestbrook Road in Horry County, as shown in detail in the Appendix.

SECTION 7: The Commission unanimously passed a motion approving the extension of existing bituminous retreatment contracts to include additional resurfacing work, as shown in detail in the Appendix.

SECTION 8: The Commission unanimously passed a motion approving the extension of existing construction contracts to include additional work, as shown in detail in the Appendix.

SECTION 9: The Commission unanimously passed a motion approving the extension of contracts beyond the contract limits, as shown in detail in the Appendix.

SECTION 10: The Commission unanimously passed a motion removing sections of roads from the State Highway System, as shown in detail in the Appendix.

SECTION 11: The Commission unanimously passed a motion rescinding its action in adding sections of roads to the State Highway System, as shown in detail in the Appendix.

SECTION 12: The Commission unanimously passed a motion transferring a section of road from the State Highway Secondary System to the State Highway Primary System, as shown in detail in the Appendix.

SECTION 13: On motion of Commissioner Jones, seconded by Commissioner Hardee, the Commission unanimously passed a motion to take into the State Highway System the 1.25 mile section of the Parkway between U. S. Route 378 and Road S-43 as an exchange for McCormick County accepting ownership and maintenance responsibility for Road S-382. The motion further authorized SCDOT staff to enter into an agreement with McCormick County to work out the details of the exchange.

SECTION 14: On motion of Commissioner Atkins, seconded by Commissioner Hardee, the Commission unanimously passed a motion approving Spartanburg County's request to participate in a match program for highway improvement projects provided that:

- the projects are in the State Highway System
- all Federal funding eligibility requirements are met
- the contribution by the Department does not exceed \$12 million in any one year
- the total amount contribute by the Department does not exceed \$84 million
- that the Department staff work with Spartanburg County staff to work out mutually acceptable participation agreements and to establish procedures for project management

SECTION 15: On motion of Commissioner Jones, seconded by Commissioner Truluck, the Commission unanimously passed a motion excusing the absence of Commissioner Self from the September 17, 1998 Commission meeting due the death of his father.

SECTION 16: There being no further business to come before the Commission, the meeting was adjourned at 5:03 p.m.

## **SURPLUS RIGHT-OF-WAY PROPERTY - LAND**

### **1. File 40.428A – Road S-2041 – Richland County**

During construction of improvements on Road S-2041, under File 40.719 in Richland County, near the City of Columbia, the Department acquired right of way for Road S-2041 by Dedication dated July 16, 1970 from Richland County.

During negotiations for settlement of an inverse condemnation case (C/A No. 96-CP-40-1704) it was determined that the subject surplus parcel should be relinquished and deeded to the adjacent owner as part of the consideration for settling this longstanding case. A gratis quitclaim deed conveying approximately 0.04 of an acre of land to Pine Forest Associates was executed on August 12, 1998.

### **2. File 40.172A – Road S-33 – Richland County**

The Department acquired right of way for construction of improvements on Roads S-33 and S-2354, under Files 40.170A and 40.738 in Richland County, near the City of Columbia, for Road S-33 by Title to Real Estate dated May 10, 1989 from Thomas E. Connelly, Jr. and from Jessie Allene Guy by Title to Real Estate dated March 3, 1989, and right of way for Road S-2354 by Right of Way Easement dated October 29, 1971 from Ernest L. Wooten and Heyward H. Fouche and by Dedication.

During negotiations for settlement of an inverse condemnation case (C/A No. 96-CP-40-1704) it was determined that the subject surplus parcels should be relinquished and deeded to the adjacent owner as part of the consideration for settling this longstanding case. A gratis quitclaim deed conveying approximately 0.11 of an acre of land (Parcel 1) and 0.36 of an acre of land (Parcel 2) to Gramercy Associates was executed on August 12, 1998.

### **3. File 7.581 – U.S. Route 278 (Cross Island Expressway) – Beaufort County**

During construction of improvements on U.S. Route 278 (Cross Island Expressway), under file 7.581 in the Town of Hilton Head in Beaufort County, the Department acquired right of way for U.S. Route 278 from HHP Limited Partnership by Deed dated May 25, 1994.

At the request of the Beaufort/Jasper Water and Sewer Authority to purchase a one acre parcel, in order to provide the Authority a site for a water tower, it was determined that the subject parcel could be relinquished. Therefore, a Quitclaim deed for 1.025 acres was prepared on June 9, 1998 for a consideration of \$70,000.00.

### **4. File 23.245A – U.S. Route I-85 – Greenville County**

During construction of improvements on U.S. Route I-85 under File 23.245A in Greenville County, near the City of Greenville, the Department acquired right of way for U.S. Route 25 relocation and Lenhardt Road from Mar-Chem, Inc. by Condemnation Notice dated November 3, 1994 and from West Gantt Baptist Church by Title to Real Estate dated August 30, 1994.

At the request of the adjacent owner to purchase back any available right of way that was condemned from him, which could be considered surplus upon project completion, it was determined by the Engineering and Right-of-Way Sections that the subject parcel could be relinquished. Therefore, a quitclaim deed for approximately 0.07 of an acre of land to Mar-Chem, Inc. was prepared on April 9, 1998 in consideration of \$4,000.00.

5. File 38.732 – Road S-1575 – Orangeburg County

During construction of improvements on S-1575, S-1575 Spur and Outfall Ditch under File 38.732 in Orangeburg County, in the Town of Springfield, the Department acquired right of way for Road S-1575 by Letter of Dedication dated November 7, 1975 from the Town of Springfield and by Right of Way Easements dated October 8, 1975 from Sophie P. Grooms and the Orangeburg County Consumer Health Council.

At the request of the County of Orangeburg for a Quitclaim deed to the right of way for Road S-1575, which was removed from the State Highway System by the Commission on July 1, 1998, it was determined that the subject parcel could be relinquished. Therefore, a gratis quitclaim deed for approximately 0.74 of an acre of land to The County of Orangeburg was prepared on August 11, 1998.

6. File 23.111A – U.S. Route 25 – Greenville County

During construction of improvements on U.S. Route 25, under File 23.111A in Greenville County, the Department acquired right of way for U.S. Route 25 by Title to Real Estate dated December 15, 1992 for Tract #87 from Samuel P. Campbell.

At the request of the only adjacent property owner, it was determined by our Engineering Sections that the subject parcel could be relinquished. Therefore, a quitclaim deed for 0.20 of an acre of land to William Dodd McCall was prepared on May 26, 1998 in consideration of \$2,500.00

7. File 26.851 – Road S-165 – Horry County

During preparation for construction of Road S-165, under File 26.851 in Horry County, near the City of Conway, the Department acquired right of way for said road by Right of Way Easements from Henry T. Rabon and Clara Annette Rabon, dated May 29, 1989, from Snow Hill Company dated May 11, 1989, from Kingston M. Long, dated May 23, 1989, from Ned J. Long, dated May 23, 1989, from Charles Long, dated June 15, 1989 and from Woodrow W. Long, dated June 15, 1989.

Prior to construction on Road S-165, the Road was removed from the State Highway System. Horry County has expressed an interest in constructing the road using Federal Funds. It was determined that the right of way the Department had acquired under the "C" Program would need to be returned and the County would be required to follow the Uniform Act in acquiring the new right of way. REQUEST FOR CONSULTANT  
CENTRAL PARKWAY AND FANTASY HARBOUR  
INTERCHANGE - HORRY COUNTY

The Department requests Commission approval to advertise, select and negotiate with consulting firms to provide engineering services for the preparation of right of way and construction plans for two segments of the new multilane Central Parkway project (RIDE Plan) between 48<sup>th</sup> Avenue North and Harrelson Boulevard. Also included will be the Fantasy Harbour interchange project (RIDE Plan) at the US Route 17 Bypass and SC Route 600 intersection, both in Horry County, South Carolina. The Department requests the option to add the completion of the construction plans for an additional segment of the Central Parkway from 10<sup>th</sup> Avenue North to US Route 501 at a later date if it is determined to be in the best interest of the Department and the project.

These projects are included in the RIDE Plan and are funded through the Horry County/State Infrastructure Bank portion of the plan.

REQUEST FOR CONSULTANT  
US ROUTE 501/GEORGE BISHOP OVERPASS – HORRY COUNTY

The Department requests Commission approval to advertise, select and negotiate with consulting firms to provide engineering services for the preparation of construction plans for the US Route 501 Frontage Road project (RIDE Plan) from the Intracoastal Waterway to Forestbrook Road in Horry County, South Carolina. Also included will be the preparation of a development report for the grade separation of George Bishop Boulevard and US Route 501 (RIDE Plan) to determine type, constructibility and feasibility of the grade separation. Upon approval of the development report by the Department, the consultant will perform the necessary work to deliver completed construction plans to the Department including environmental work. The George Bishop Overpass plans will be developed concurrently with the construction plans for the US 501 Frontage Roads as associated with the determination of which structure to elevate.

These projects are included in the RIDE Plan and are funded through the Horry County/State Infrastructure Bank portion of the plan.
