Chairman Waldrep called the meeting to order and Mr. Tom Martin gave the invocation.

Mr. Waldrep explained the reason for the called meeting was to talk about the structure of the Planning & Development Board. He said he felt like there was a need for a meeting because of the amount of discussion and amendments at the last meeting which caused confusion. He recognized Mr. Watson. Mr. Watson said that it would be wise to proceed on with a County area under the Administration for the Planning part of County government and his recommendations are not only based on the COG study but in other Counties, industrial recruiting and Planning and Development are separated. There would be complete County control of the industrial recruiter as well as planning and development. The 9-1-1 system should remain with the Planning group because of the mapping requirements. Mr. Banister moved to adopt the structure outlined by Mr. Watson which divides Industrial Recruiting from Planning and to include the members of the Planning and Development Board with the job search. He said that he was confused at what was voted on at the last meeting. Mr. Allgood seconded the motion. Council discussed. Mr. Holden said he was not sure that this was the recommendation of the County Administrator. Vote was three in favor (Waldrep, Allgood, Banister) and one opposed (Holden). Motion carried.
