**SUMMARY:**

- Dr. Gué dedicated over 40 years to the city of Orangeburg with his private medical practice. Was in private medical practice from 1963-2007.
- Upon his retirement, he established the Orangeburg-Calhoun Free Medical Clinic which provides medical care for the uninsured indigent population in Orangeburg and Calhoun counties at no cost, where he has served as Medical Director since 2009. In 2013, the clinic served 450 patients who made 2,225 visits to the clinic.
- He volunteers his time and expertise as an unpaid physician to these patients and pursues new avenues for funding to sustain the clinic by fostering good relationships with the people of these communities.
- The clinic utilizes nurse volunteers from the local colleges as well as students from the Orangeburg-Calhoun Technical Colleges LPN Program. These students gain invaluable experience and carry their work into the nursing field across the state.
