The Budget Commission met in the Senate Finance Committee Room at 10:00 o'clock A. M., on October 27, 1942, all members being present.

South Carolina Tax Commission

From Income Tax (Revenue Account), Section 2458 (5) Appropriation Bill 1942-43 \$4,635.00 - To Item 3, Income Tax Division, Stenographer \$1125.00, Clerks (2) \$2160.00 and Auditor \$1350.00.

The following allotments from the 1942-43 Civil Contingent Fund were granted by the Commission:

Secretary of State, \$150.00 for Election Expense
Comptroller General's Office \$150.00, Treasurer's salary for one month, Newberry County.
Governor's Office \$1,000.00, for Special Investigations.
State Superintendent of Education \$150.00 to cover cost of a radio broadcast in connection with the School Milk Program.

The following allotment was granted from the 1941-42 Civil Contingent Fund:

Department of Labor \$100.00, for salary of statistical clerk for one month. This clerk had entered the armed forces of the United States.

The following allotment was granted from the Contingent Fund for National Defense:

Governor's Office \$3600.00, for Motor Vehicles and Equipment for the Law Enforcement Division.

The Commission declined to approve a transfer of \$9,000.00, requested by the Unemployment Compensation Commission from the appropriation for the Employment Service to the Administration Fund of the Commission, for salaries of the Commissioners.

The Commission had before it a request from Mr. Charles O. Hearon, Secretary of the Chamber of Commerce of Spartanburg, S. C., requesting a further contribution from the Civil Contingent Fund for the Control of Venereal Diseases in Spartanburg County. The Secretary was instructed to advise Mr. Hearon that the Commission did not have sufficient funds to make a further allocation for this purpose.

The Commission had before it a letter from Mrs. Maude Massey Rogers requesting an appropriation to support the work of the State Library Board for the year 1943-44. Action on this request was deferred until the matter of the Commissions' recommendations on the 1943-44 appropriations was under consideration.

The Commission approved a range of salaries payable by the South Carolina Unemployment Compensation Commission, effective September 1, 1942.

The Commission then adjourned.
