Afternoon Update from Kim Stenson:

County & State Resources: EMD conducted a county call this morning and there were no unmet needs. There have been no requests for state assistance. Tomorrow at 10:00 a.m., EMD will conduct another county call to assess any needs.

Sheltering: Many counties have opened or will open warming and/or general population shelters dependent on electric restoration. There may be a need to open special medical need shelters but that will also be dependent on electric restoration. Shelter population in both type shelters is expected to be low.

Road Conditions: Depending on road conditions (refreezing), there may some county office delays Wednesday morning.

Other: Power was restored to the Abbeville 911 center this morning.

Damage: Damage assessment at the local level is ongoing, but current estimates indicate that this event will not be of the magnitude to reach the criteria of a federal declaration. However, it will take at least two days, perhaps longer, to get a better damage estimate.

Mid-Day Update on Road Conditions and Outages:

Road Conditions: (conditions improving)

- All precipitation has ended. The northwestern third of the state continues to have significant ice accumulation on roads with power outages and downed trees. Temperatures in Spartanburg are remaining at or slightly above freezing. Interstates, priority routes, and bridges continue to be treated for de-icing.
- State Resources used thus far:
 - 768 DOT maintenance employees actively involved in road operations;
 - 5,739 tons of salt and 1,896 tons of sand;
 - 17,892 gallons of calcium chloride and 523,520 gallons of salt brine;
 - 320 pieces of equipment in use.

Outage Numbers: (outages decreasing)

- Duke: 70,625
- SCE&G: 680
- Co-ops: 19,992
- Municipalities: 5,823

Total Outages: 97,120

Restoration Time: Mostly today; some tomorrow (Blue Ridge and Laurens)
