I WAS TOLD BY THE STAFF OF THE PRISON OF WICH I AM CURRENTLY BEING HOUSED THAT I SHOULD ATTEMPT TO CONTACT YOUR OFFICE AND INFORM YOU OF THE EVENTS AND IF I WERE TO STILL NOT GET ANY KIND OF RESPONSE, THEN I SHOULD TURN OVER THE EVIDENCE TO THEM AND THEY WOULD INTURN TURN OVER THE EVIDENCE TO THE LOCAL PRESS AND NEWSPAPER.

SO I'LL GIVE YOU A SHORT DETAILED BRIEF ON THE SITUATION.
