





I am writing to share my concern over recent Medicaid changes that have been made to physical, occupational and speech therapy. I understand that physical and occupational therapy will be limited to 50 sessions per year and speech therapy will be limited to 100 sessions per year. I also understand that Medicaid has decided to begin counting these services retroactively back to July 1, 2008. This is the area of greatest concern for me. My five year old son has Down syndrome and attends the Meyer Center for Special Children in Greenville. He has been receiving therapy services there during this time frame and the center has been billing them to Medicaid in good faith that they will be reimbursed for them. It does not seem ethical for Medicaid to change their program retroactively. The Meyer Center and other agencies across the state have built budgets with the expectation that they will be paid for the services that were provided during the last six months. It is my hope that you will support disabled children across the state and ask that retroactivity be appealed immediately.

Dear Ms. Freeman:

Thank you for your recent letter of January 29, 2009 to Senator Fair regarding your concerns about proposed Medicaid cuts in therapy services. Senator Fair has asked that we respond directly to you.

As a result of significant state revenue shortfalls, the Medicaid budget for the South Carolina Department of Health and Human Services (SCDHHS) has been reduced by \$137 million or 15% of the agency's general fund budget. Over 55% of the state Medicaid budget is federally mandated. When state funds are lacking, budget cuts are limited to our optional programs; unfortunately, rehabilitative therapy services fall into this category.

To date, all Medicaid programs scheduled for changes have been placed on hold in anticipation of additional funding from the Federal Government's Recovery and Reinvestment Act of 2009 and other legislation which will include increased funding to the states as a result of rising unemployment and increasing state Medicaid rolls. It is anticipated that the additional dollars allocated to South Carolina will allow us to continue to provide reimbursement for most of these services, but the agency will continue to scrutinize every provision to ensure that needs of South Carolina's beneficiaries are met.

We are exploring implementation of an authorization process for private therapy so that beneficiaries can continue to receive medically necessary services. This policy development will include input from providers and parents. We hope to have a new policy in place that is both fair and equitable.

We will continue to work during these challenging budget times to meet medical needs in our state. We appreciate your input, and we thank you for your patience.




