So I think there was just a typo in the data we sent over. SFY 2015 should only have 2 cases of Hyde Amendment abortions, not 5. We didn't mean to change the numbers from the prior report (which showed there was only 2) so I think that should make the dollars make more sense but any difference in average cost per Hyde-compliment abortions would be related to severity.
