Justice Kennedy: SCOTUS Should Re-examine Quill

There is no way to know for sure why Justice Kennedy wrote a concurring opinion in *Direct Marketing Association v. Brohl* stating that the "legal system should find an appropriate case for this Court to reexamine *Quill*." But even if you don't read the State and Local Legal Center (SLLC) *amicus* brief's criticism of *Quill* and merely scan its table of authorities, you will notice that two of the three non-case related

citations in Justice Kennedy's opinion come from the SLLC's brief.
