The regular monthly meeting of the Department of Transportation Commission was held at the Greenville Chamber of Commerce Board Room in Greenville, South Carolina at 10:00 a.m. on August 21, 2003. In compliance with the Freedom of Information Act, the news media was advised in writing of the time, date and place of this meeting.

SECTION 1: On motion of Commissioner Truluck, seconded by Commissioner Mack, the Commission unanimously passed a motion excusing the absence of Commissioner Harrell. Commissioner Truluck cast proxy votes for Commissioner Harrell.

SECTION 2: On motion of Commissioner Mack, seconded by Commissioner Clyborne, the Commission unanimously passed a motion approving the July 24, 2003 Commission Minutes; copies of which had been previously mailed to each member of the Commission.

SECTION 3: The Commission unanimously passed a motion approving the sale of surplus right of way property, as shown in detail in the Appendix.

SECTION 4: The Commission unanimously passed a motion approving non-urban area transportation 2003 enhancements projects, as shown in detail in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the request of the Department for a \$100,000 grant from the mass transit funds to the Greenville County Economic Corporation to assist in the costs associated with the north/south rail line project in Greenville.

SECTION 6: The Commission unanimously passed a motion accepting into the State Highway System for construction the proposed road in Chester County connecting McCandless Road (S-329) and SC 72 Bypass, approximately 0.95 mile in length. The Department will not accept maintenance on this road until it meets state standards.

SECTION 7: The Commission unanimously passed a motion authorizing the Department to seek a professional engineering consultant to perform work on several bridges in various counties, as shown in detail in the Appendix.

SECTION 8: The Commission unanimously passed a motion authorizing the Department to advertise and select a vendor to provide 2070 Traffic Signal Controllers and Software, as shown in the Appendix.

SECTION 9: The Commission unanimously passed a motion approving the action of the Department in extending existing construction contracts beyond the contract limits, as shown in detail in the Appendix.

SECTION 10: The Commission unanimously passed a motion approving the action of the Department in extending an existing bituminous retreatment contract to include additional resurfacing, as shown in detail in the Appendix.

SECTION 11: The Commission unanimously passed a motion approving the action of the Department in extending existing construction contracts to include additional work, as shown in detail in the Appendix.

SECTION 12: The Commission unanimously passed a motion approving the action of the Department in correcting the description of sections of State Highways previously added to the State Highway System, as shown in detail in the Appendix.

SECTION 13: The Commission unanimously passed a motion approving the action of the Department in adding sections of roads to the State Highway System, as shown in detail in the Appendix.

SECTION 14: The Commission unanimously passed a motion approving the action of the Department concerning projects in the highway letting of July 8, 2003, as shown in detail in the Appendix.

SECTION 15: The Commission unanimously passed a motion approving the action of the Department revising action taken at the July 10, 2003 highway letting, as shown in detail in the Appendix.

SECTION 16: The Commission unanimously passed a motion approving the action of the Department concerning projects in the highway letting of July 15, 2003, as shown in detail in the Appendix.

SECTION 17: On motion of Commissioner Stoddard, seconded by Commissioner Mack, the Commission unanimously passed a motion approving the request of Representative Wallace Scarborough and the Charleston County Legislative Delegation to name the new Stono River Bridge in Charleston County the "Paul J. Gelegotis Bridge".

Commissioner Hardee abstained from voting on this motion.

SECTION 19: On motion of Commissioner Mack, seconded by Commissioner Clyborne, the Commission unanimously passed a motion approving a request from the City of North Myrtle Beach to include the top five reasons for funding the North Myrtle Beach Connector in the Commission Minutes, as shown in detail in the Appendix.

1. File 23.245A / Route I-85 / Greenville County

During construction of improvements on Route 291, File 23.340/US Route 25, File 23.358 in Greenville County, near the City of Greenville, the Department acquired right of way by Title to Real Estate from Richard C. Lee dated February 4, 1954.

A request was received from Sara Lee Bakery Group requesting the reduction of right of way between SC 20 Ramp 2 of Interstate I-85 and their adjoining property to expand the parking area and to facilitate in the expansion of the plant. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.95 of an acre of land to Sara Lee Bakery Group was executed on April 25, 2003 in consideration of \$25,000.00.

2. File 40.686 / US Rte 1 / Richland County

During construction of improvements on US Route 1 (Two Notch Road), under File 40.686 in Richland County, near the Town of Columbia, the Department acquired right of way for US Route 1 (Two Notch Road), by Notice of Condemnation from Margaret L. Elkin, dated March 6, 1969.

A request was received from an attorney representing Larry A. Pyle, requesting a corrective quitclaim deed from the Department. This is a replacement deed for one issued by SCDOT on October 20, 2002. Therefore, a Corrective Quitclaim for approximately 0.16 of an acre of land to Larry A. Pyle and Associates, Inc. was executed on July 17, 2003.

3. File 23.474 / SC Rte 14 / Greenville County

During construction of improvements on SC Route 14, under File 23.474A in Greenville County, near the City of Greenville, the Department acquired right of way for SC Route 14 Relocation, by Title to Real Estate from Kenneth C. & Sarill Cosgrove dated April 4, 2000.

In order to settle a difficult acquisition case, the Department entered into an agreement with Kenneth & Sarill Cosgrove to allow them to purchase back any adjacent surplus property when the project was complete. The Grantee agreed to assist the Department by removing any existing improvements located within the new right of way. Therefore, a Quitclaim Deed for approximately 0.69 of an acre of land to Vineland Construction Company was executed on June 5, 2003 in consideration of \$33,490.00.

4. File 40.382 / SC Rte 555 / Richland County

During construction of improvements on SC Route 555, under File 40.382 in Richland County, near the City of Columbia, the Department acquired right of way for SC Route 555, by Deed to Right of Way from S.C. Mental Health Commission dated January 20, 1956 and from Mrs. Ruby M. Jones by Deed to Right of Way dated December 19, 1955.

A request was received from an attorney representing SCE&G, requesting a quitclaim deed from the Department conveying all right title and interest of the Department in a portion of old Harden Street to clear any interest that the Department may have in the subject area. This is a replacement deed for one issued by SCDOT on June 20, 1986 but was never recorded and lost by the previous property owner, SC Department of Mental Health. Therefore, a Gratis Quitclaim for approximately 0.53 of an acre of land to South Carolina Electric & Gas Company was executed on July 30, 2003.

5. File 23.246A / Interstate I-85 / Greenville County

During construction of improvements on Interstate I-85, under File 23.246A in Greenville County, near the City of Greenville, the Department acquired right of way for US Route 25 Business/SC Route 291 Frontage Road, by Condemnation from Bernice Anne Williams Steinmeyer dated June 16, 1992, and by Title to Real Estate from Richard W. Locke dated November 16, 1992, and by Title to Real Estate from Evelyn Jeanette Surratt dated October 4, 1993.

During the process of liquidating uneconomic remainders of low value in Greenville County, the Department extended Right of First Refusal to the original property owners due to the circumstances of the acquisition of these parcels. These remainders were circulated to our engineering sections and declared surplus. Therefore, a Quitclaim Deed for a total of approximately 0.582 of an acre of land to Evelyn Jeanette Surratt was executed on July 30, 2003 in consideration of \$5,900.00.

6. File 7.558 / US Route 278 / Beaufort County

During construction of improvements on US Route 278, under File 7.581 in Beaufort County, near the Town of Hilton Head Island, the Department acquired right of way for US Route 278, by Title to Real Estate from Howard Nilson dated February 20, 1998.

The Department determined that the subject tract of land was surplus to the Department's needs and could be put up for sale. The property was marketed to the general public with signs, newspaper ads, and all necessary means to attract a qualified buyer. A bid sale was set up and consummated with the Grantee offering the highest bid. Therefore, a Quitclaim Deed for approximately 2.4-acres of land to Town of Hilton Head Island was executed on July 16, 2003 in consideration of \$168,000.00.

7. File MSC 126 / SC Route 302 / Aiken County

In order to provide better maintenance service to the city of New Ellenton, in Aiken County, the Department acquired property for a new maintenance facility known as MSC 126 by Title to Real Estate from B.O. Johnson dated February 9, 1951.

The District Engineering Administrator of District 1, with concurrence of management, has determined that the Maintenance Shed near New Ellenton is no longer needed and should be liquidated from the Department's inventory. After receiving approval from the South Carolina Department Budget and Control Board, the property was marketed to the general public with signs, newspaper ads, and all necessary means to attract a qualified buyer. A bid sale was set up and consummated. The Grantee offered the highest acceptable bid higher than the appraised value of \$12,000.00. Therefore, a Quitclaim Deed for approximately 1.95 acres of land to William Thomas Robinson, Jr. was executed on July 2, 2003 in consideration of \$12,500.00.

8. File MSC 33 & 120 / US Route 78 / Aiken County

In order to provide better maintenance service to the city of Aiken, in Aiken County, the Department acquired property for a new maintenance facility known as MSC 33 and MSC 120 by Title to Real Estate from Eugene H. Kneece dated April 20, 1951 and by Title to Real Estate from Mrs. Allie A. Gaston dated April 19, 1937.

The District Engineering Administrator of District 1, with concurrence of management, has determined that the Maintenance Shed in Aiken is no longer needed and should be liquidated from the Department's inventory. The property was marketed to the general public with signs, newspaper ads, and all necessary means to attract a qualified buyer. A bid sale was set up and consummated. The Grantee offered the highest acceptable bid which was higher than the appraised value of \$103,700.00. Therefore, a Quitclaim Deed for approximately 3.8 acres of land to S R Properties, LLC was executed on July 28, 2003 in consideration of \$175,001.00.

9. File 7.623 / SC Route 802 / Beaufort County

During construction of improvements on SC Route 802, under File 7.623 in Beaufort County, near the Town of Port Royal, the Department acquired right of way for the existing Road S-72 (Brickyard Point Road), by Beltline Act dated July 15, 1951.

In order to settle a difficult acquisition case, the Department agreed to convey a small piece of surplus right of way to the adjacent property owner as partial payment for the new right of way needed for Road S-72 Relocation (Brickyard Point Road). Therefore, a Gratis Quitclaim Deed for approximately 0.75 of an acre of land to Roxanna Roe Pratt, Bruce G. Pratt, Jr., Thomas N. Pratt, and Sara Katherine Pratt was executed on July 31, 2003.

10. File 10.439A / Road S-97 & Road S-72 / Charleston County

During construction of improvements on Road S-97 & Road S-72, under File 10.439A in Charleston County, near the Town of Mount Pleasant, the Department acquired right of way for Road S-97 & Road S-72, by Title to Real Estate from Davis Terry, L.P. dated August 23, 2000.

The Department received a request from the Town of Mount Pleasant asking the Department to convey a detention pond, recently constructed as part of the Road S-97 (Long Point Road) and Road S-72 (Whipple Road) widening project. Because the Town of Mount Pleasant plans additional improvements to the open ditches adjacent to the pond, the Town has further agreed to take over the maintenance of the subject parcel. Therefore, a Gratis Quitclaim Deed for approximately 1.08 of an acre of land to the Town of Mount Pleasant was executed on August 4, 2003.

11. File 16.336 / Road S-53 / Darlington County

During construction of improvements on Road S-53, under File 16.336 in Darlington County, near the Town of Clyde, the Department acquired right of way for Road S-241 (Gum Branch Road), by Beltline Act from dated May 20, 1954.

The Department received a request from the DEA of District 5, asking the Department to abandoned Old Road S-241 from the highway system and convey it to Darlington County. Darlington County has agreed to take over the maintenance of the road. Therefore, a Gratis Quitclaim Deed for approximately 0.78 of an acre of land to Darlington County was executed on July 31, 2003.

Request for Funding for the North-South Rail line in Greenville South Carolina

The Department requests approval of a \$100,000 grant from the mass transit funds to the Greenville County Economic Corporation to assist in the costs associated with the north/south rail line project in Greenville.

REQUEST FOR PROFESSIONAL ENGINEERING SERVICES FOR:

SEVERAL BRIDGES IN VARIOUS COUNTIES

These projects will be funded through Bridge Replacement Program.

- 1] SC 917: Bridges over Little Pee Dee River and Swamp in Horry and Marion Counties
- 2] SC 41: Bridge over Wando River in Berkeley County
- 3] US 17: Bridge over Combahee River in Beaufort and Colleton Counties

The Department has received an additional 21 million for bridge replacements in FY 03 and FY 04 in addition to the current program. These services are needed to allow staff to complete current projects and have projects ready to advance to letting in the upcoming fiscal year to obligate available funds.

Suppliers for 2070 Traffic Signal Controllers and Software

The Department request Commission approval to advertise and select a vendor to provide 2070 Traffic Signal Controllers and Software.

Recommendations: 08/21/03

EXTENSION OF CONTRACTS BEYOND CONTRACT LIMITS

It is recommended the Commission approve the extension of the following contracts beyond the contract limits as follows:

BERKELEY COUNTY:

Contract of Hinkle Contracting Corp. - File No. 8.2001 - extended to include an additional section of Project HMP-HIMP(202) (File No. 8.2001) consisting of resurfacing on S-644 and S-50 for a total of 0.63 mile.

SUMTER COUNTY:

Contract of APAC-Atlantic, Inc. - File No. 43.103C - extended to include an additional portion of Project C-103C (File No. 43.103C) consisting of resurfacing on Road S-454 for 1.23 miles.

Estimated Cost of Extension

\$105,215.32

This extension was authorized by the Department prior to formal approval by the Commission since the adjacent work had reached such a stage of completion that the contractor involved could not accept the additional work unless it were authorized without delay.

EXTENSION OF CONSTRUCTION CONTRACTS

It is recommended that the Commission approve the action of the Department in extending existing construction contracts to include additional work as follows:

CHARLESTON COUNTY:

Contract of Banks Construction Company, Inc – File No. 10.57031 - extended to include replacement (File 10.368A) of existing drainage and widening of shoulders on SC 61.

Estimated Cost of Extension \$ 87,973.38

CHESTERFIELD COUNTY:

Contract of APAC-Atlantic, Inc. – File No. 13.103C - extended to include an additional section of Project C-103C (File No. 13.103C) consisting of the addition of a drainage system to S-949 for 0.17 mile.

Estimated Cost of Extension \$ 34,835.00

GREENVILLE COUNTY:

Contract of APAC-Southeast, Inc. – File No. 23.227A – extended to include an additional section of Project FAP BIU-IIBM(001) (File No. 23.227A) consisting of resurfacing on Hunters Woods Drive and Hunters Hill Road for 0.72 mile.

Estimated Cost of Extension \$ 96,903.35

HORRY COUNTY:

Contract of Southern Asphalt, Inc. - File No. 47.100B - extended to include an additional section of Project ER-TRFL(001) (File No. 26.2000.1) consisting of the addition of a crossover on US 501.

The top 5 reasons for funding the North Myrtle Beach Connector:

1. **3.5 million visitors stay overnight in North Myrtle Beach annually. We have 17,000 rooms in 8,000 seasonal rentals (2001 data).** This is a full one-third of the number of seasonal rooms and units available in Horry County. About 1,000 new units per year have been built in the last six years in North Myrtle Beach.
2. **\$97.5 million is spent on accommodations and \$372 million in gross receipts from net taxable sales are generated in North Myrtle Beach annually.** These figures will suffer if our guests choose to go elsewhere (like Florida, North Carolina or Virginia) because they cannot easily get to their accommodations and or easily get around the Strand.
3. **Up to 90,000 vehicles per day travel on US 17 and all intersections are operating at level D or below throughout the summer season.** For comparison, the Carolina Bays Parkway is projected to have 80,000 vehicles per day in 2020.
4. **Only one bridge provides hurricane evacuation across the Intracoastal for about 70,000 people staying in North Myrtle Beach during peak season.** The Little River swing bridge has to stay open for boat traffic. Barefoot Resort swing bridge and the Conway Bypass provide additional crossings to the south, but US 17 reaches capacity quickly at that end of the city.
5. **Future growth:** there is still about 1400 acres of undeveloped land on the east side of the waterway. Building the Connector now will help accommodate future growth as well.

The Connector is needed for local connectivity as well. It will connect the city to the county for local trips such as quick access to schools and will also connect the county to the beach and businesses.
