**Request Details:** TODAY [MONDAY, NOVEMBER 30] PRESIDENT OBAMA IS SCHEDULED TO MEET WITH 100 WORLD LEADERS. I, THE HONORABLE PATRICK L. BOOKER, LL.M., DO HEREBY REQUEST THAT YOU IMMEDIATELY NOTIFY THE PRESIDENT, PURSUANT TO AND IN ACCORDANCE WITH TITLE 22 U.S.C. SECTION 1732, THAT I, AN AMERICAN CITIZEN, HAVE HEREBY MADE KNOWN AND PROCLAIMED TO YOU THAT I AM UNJUSTLY DEPRIVED OF MY LIBERTY IN VIOLATION OF MY AMERICAN CITIZENSHIP, BY AND UNDER THE AUTHORITY OF A PARTICULAR FOREIGN GOVERNMENT, AND THAT I AM REQUESTING PRESIDENT OBAMA TO PROMPTLY AND FORTHWITH TO INQUIRE AND TO DEMAND OF THAT FOREIGN GOVERNMENT [SOUTH CAROLINA SUPREME COURT JUSTICE MEMBERS JEAN TOAL, COSTA PLEICONES, DONALD BEATTY, JOHN KITTREDGE, AND KAYE HEARN] OF THE REASONS WHY THEY DEPRIVED ME OF COURT ACCESS AND OF LAWFUL DUE PROCESS, IN VIOLATION OF TITLE 18 U.S.C. SECTION 241 AS WELL AS SC CODE OF LAW SECTION 16-5-10, WHICH HAS KEPT ME UNJUSTLY DEPRIVED OF MY LIBERTY IN VIOLATION OF MY AMERICAN CITIZENSHIP. SEE 2012-CP-23-02384.

**Request Details:** PER ATTORNEY GENERAL OPINION NO. 1993 WL 524194, "ANY CITIZEN WHO HAS REASONABLE GROUNDS TO BELIEVE THAT THE LAW HAS BEEN VIOLATED HAS THE RIGHT TO CAUSE THE ARREST OF A PERSON WHO HE HONESTLY AND IN GOOD-FAITH BELIEVES TO BE THE OFFENDER." AND PER SECTION 17-13-10 OF SC CODE OF LAWS, YOU [GENERAL COUNSEL] ARE EMPOWERED WITH THE STATUTORY AUTHORITY TO ARREST ANY FELON AND TO TAKE THE FELON TO A JUDGE OR MAGISTRATE TO BE DEALT WITH ACCORDING TO LAW, UPON CERTAIN INFORMATION THAT A FELONY HAS BEEN COMMITTED. ACCORDINGLY, I HEREBY RESPECTFULLY ENLIST, ENTREAT, AND IMPORE YOU TO GO ARREST SUPREME COURT JUSTICE MEMBERS JEAN TOAL, COSTA PLEICONE, DONALD BEATTY, JOHN KITTREDGE AND KAYE HEARN FOR THEIR VIOLATION OF 16-5-10 WHERE THEY DENIED ME LAWFUL DUE PROCEDURE OF LAW.
