

### **Evidentiary Supporting Documentation Requested**

I need the following supporting documentation or access to the same to ensure a fair trial. This information, if it exists, more likely than not resides within the South Carolina Department of Social Services, a State agency under your control as Governor of South Carolina:

1. A copy of all Family Court orders reflecting my legal name which is Phillip Maurice Hicks or my nickname which is "Marty Hicks" including but not limited to the original child support order with any amendments. I need a copy of all orders even if not executed/signed by a Family Court judge (Exhibit B speaks of an unsigned order).
2. Detailed calculations and/or determining factors of the monthly child support ordered by the Family Court of \$1,189.00 including *all* supporting documentation thereof (Exhibit E).
3. Detailed calculations and/or determining factors of the support arrearage of \$64,919.40 as of the hearing date including *all* supporting documentation thereof (Exhibit E).
4. A detailed schedule of *all* payments including payment dates made by the Respondent South Carolina Department of Social Services or its Charleston County affiliate to Co-Respondent Neva G Dewall on behalf of Samantha H.

5. Documentation of any Change in Financial Condition filed by Co-Respondent Neva G Dewall with the Respondent South Carolina Department of Social Services or its Charleston County affiliate, if any.

6. Any and *all* supporting documentation Co-Respondent Neva G Dewall provided to the Family Court and/or to the Respondent South Carolina Department of Social Services or its Charleston County affiliate which was used as a basis or a determining factor for any portion of the calculation of the monthly child support ordered by the Family Court of \$1,189.00 and the support arrearage of \$64,919.40 as of the hearing date, if any.

7. Any and *all* third party documentation used in the calculation or determination of the monthly child support ordered by the Family Court of \$1,189.00 and the support arrearage of \$64,919.40 as of the hearing date which reflects my legal name or nickname which is "Marty Hicks", if any. This type of documentation includes but is not limited to; tax filings, court filings outside the 9<sup>th</sup> Circuit jurisdiction, printed website pages *etc...*, if any.

8. I also need the legal name of the special solicitor provided by the South Carolina Department of Social Services who supported the regular solicitor for the State of South Carolina in the Criminal Domestic Violence trial against me (Exhibit G). I need the legal name of the Charleston County Deputy Sheriff who testified against me at the Criminal Trial and provided Neva G. Dewall with legal advice (Exhibit G). I need the legal name of the Charleston County Deputy

Sheriff, the Berkeley County Deputy Sheriff and the name of the US Customs Officer who served the Bench Warrant without reading my rights (Exhibit D). If necessary and at your request, I will provide a video clip to assist you in identifying the law enforcement officers who served the bench warrant.

### **Official Request**

As an American citizen, I am entitled to a fair trial with due process and procedural safeguards for the same. First, to ensure a fair trial in the Court of Appeals in the State of South Carolina, I need certain evidentiary supporting documentation, *supra*, which is highly likely held by or in the possession of the South Carolina Department of Social Services. I currently do not have this documentation or access to it. Accordingly, I petition you to provide or make available said evidentiary supporting documentation as the Governor of South Carolina in your official capacity with ultimate control over the operations of the South Carolina Department of Social Services. In the unlikely event you refuse to provide this information in your official capacity, according to South Carolina Code of Laws, Title 30, Chapter 4, § 30-4-30 I have a right to this evidentiary supporting documentation regardless. In that respect, I am *dually* petitioning you to provide or make available this information in accordance with the South Carolina Freedom of Information Act. As is customary, I will make arrangements

to pay for all administrative costs of producing this documentation such as copy charges upon notification. Alternatively, you can make the information available to me or my authorized representative to copy. If the South Carolina Department of Social Services does not have the evidentiary supporting documentation requested, please respond with a statement to that effect.

Second, I petition you to immediately initiate an action to stay the *per se* fraudulent *and* unconstitutional child support payments ordered by the Family Court until such time I successfully contest the adoption and restore *normal* child support, custody determination or visitation determined without prejudice.

Since I am a *pro se* Appellant and unsure as to the full operation and applications of this relatively new law, the South Carolina Attorney General is copied hereto to ensure full compliance with the South Carolina Freedom of Information Act, South Carolina Code of Laws, Title 30, Chapter 4, § 30-4-30 in his official capacity.

My initial brief for the case on appeal is due to be filed on or before April 11, 2012 and the next *per se* fraudulent child support payment is due on March 26, 2012. It would be very helpful to my case to include the requested documentation in my initial brief. In that regard, please respond to my requests within 10 days if possible. If that is not possible, please respond or have your office respond with a short letter to that effect.
