
It has come to my attention that SCDHHS has recently released outpatient hospital multipliers which convert the statewide outpatient hospital FFS reimbursement schedule to hospital-specific effective July 4, 2008 and retroactive October 2007.

These multipliers reflect a significant increase in reported hospital costs. On behalf of all MCO's participating in the South Carolina Medicaid Program, I would like to meet with you as soon as possible to discuss your timeline for the updating of the managed care rates to reflect this increased cost, as this change has a direct impact on the financial health of the MCO's.

In addition, I would like to discuss the possibility of a methodology of including the MCO's on these decisions prior to implementation. Our actuary acted very quickly to indicate to us the material impact of this decision on the MCO's. We would like to review our findings with you to assist in your updating of the MCO rates accordingly.

This issue is paramount to the financial viability of our MCO's. I appreciate your prompt attention to this matter.

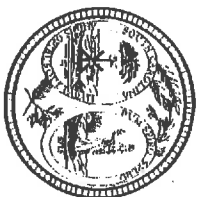

Thank you for your letter of June 27, 2008, regarding your concerns about a recent update to Medicaid outpatient hospital reimbursement methodology and potential financial impact on Managed Care Organizations (MCO's).

It is my understanding that you had a productive meeting with members of my staff on July 2, 2008. As discussed in the meeting, SCDHHS will be happy to review analysis and estimated financial impact prepared by your actuary. As you know, our ability to address Medicaid rate issues in general is constrained by our budget, and we will carefully consider your request in consultation with our actuaries.

In conjunction with the rate setting process for the April 1, 2009 MCO rates, SCDHHS actuaries will review fee for service (FFS) data and MCO encounter data to analyze the financial impact of the outpatient multiplier on FFS claims and MCO encounters retrospectively to October 2007. The SCDHHS actuaries will take this data into consideration in setting the April 1, 2009 rates and will also be asked to recommend any retrospective adjustment that may be required to maintain the actuarial soundness of the MCO rates paid between October 1, 2007 and March 31, 2009.

I hope this meeting helped to resolve your concerns. Please be assured that we value the role of the MCO's in serving our Medicaid beneficiaries, and we will continue to strive to maintain open lines of communication and transparency in the rate-setting process.
