Dear Governor Haley:

I have never contacted you before; I've always thought that you had earned the right to make the decisions concerning the State's business without citizens trying to sway you. And I see that you have done some great things for our state. Many new industries have brought jobs bearing decent wages to the people of South Carolina, and I attribute that solely to you, and I thank you for that!

However, new information has surfaced that prompts me to speak out against your decisions to allow the Refugee Resettlement Program to continue bringing foreigners into Spartanburg and Greenville, and perhaps to other towns in the state. Certainly, the program had held merits in the past, but I believe this program brings a huge risk to South Carolinians now, because of President Obama's changes to the guidelines employed by the United States in deciding who is allowed refugee status.

I've attached the following information from Instigator News Network, as penned by Bob Bennet:

"February 5, 2014: Obama Administration Unilaterally Changes Federal Law Prohibiting Admission of Terrorists to U.S.

"The Departments of Homeland Security and State publish[ed] new regulations to narrow a ban in the INA prohibiting individuals who had provided "limited" material support to terrorists from entering the country. The regulations would excuse activities such as:

- Committing or inciting to commit, under circumstances indicating an intention to cause death or serious bodily injury, a terrorist activity;
- Preparing or planning a terrorist activity; gathering information on potential targets for terrorist activity; soliciting funds or other things of value for terrorist activity;
- Committing an act that the actor knows, or reasonably should know, affords material support, including a safe house, transportation, communications, funds, transfer of funds or other material financial benefit, false documentation or identification, weapons (including chemical, biological, or radiological weapons), explosives, or training for the commission of a terrorist activity.

"Under the new administration policy, such individuals would be permitted not only to enter the country, but to apply for any immigration benefit, including permanent resident status."

Terrorists may now be allowed to enter the United States as a refugee. This is totally unforgivable, and Christian church organizations are being duped into helping with this. The past success of the refugee program has no bearing on the refugees that are scheduled to arrive in the near future.

The news tells us that 70% of the current refugees are males, and perhaps only 3% are Christian. That tells me that we will be opening up our city to Muslims who will forever change the face of our great town. Their culture is very violent, with rape and child molestation being a common occurrence. Furthermore, ISIS brags that they have over 4,000 terrorists planted in the refugee program now, with their goal of

coming to America to establish their caliphate here. I cannot fathom the continuation of this program, given the unpleasant information that is now available to us....it is nothing short of evil.


Senator Jeff Sessions tells us that ***"We do not have adequate resources or records and will not conduct any meaningful investigation of each of the thousands of applicants."***
