Colonel Mark C. Easton, U.S. Army (Retired) is the Principal Secretary to the United Nation's Military Staff Committee. He plans and coordinates the work of the Permanent Five Security Council Member's Military Advisers (China, France, Russia, United Kingdom, and United States).

Prior to his retirement on 1 September 2009, COL Easton served as the Chief of Staff, United States Military Staff Committee, J5/Joint Chiefs of Staff, serving at the U.S. Mission to the United Nations in New York City.

COL Easton spent most his career in overseas assignments. Most recently, he served as the Defense and Army Attaché at the U.S. Embassy in Belgrade, Serbia. He worked closely with the Serbian Ministry of Defense and General Staff during the Montenegrin independence referendum, Serbia's entry in NATO Partnership for Peace (PfP) and helped coordinate interaction between NATO Kosovo Forces (KFOR) and Serbian Armed Forces along the Administrative Boundary Line with Kosovo.

Prior to Serbia, COL Easton was the Army Attaché at the U.S. Embassy in Kiev, Ukraine. He planned and coordinated with the Ukrainian Armed Forces to deploy their 1,600 soldier brigade contingent to Iraq in 2003 as part of Multinational Division-North. COL Easton also served in Bosnia and Herzegovina, Germany, Russia, and United States at various levels of the Army.

Mark Easton is a graduate of the United States Military Academy at West Point, New York. He holds a Masters of Business Administration from Boston University, a Masters in International Affairs from Columbia University, and a Masters in Strategic Studies from the U.S. Army War College. He has passed the UN language proficiency exam in Russian. He continues his French Language studies at Level 6 in the UN Language Program. He completed Level 2 Advanced Training on Security Sector Reform with the International Security Sector Advisory Team of the Geneva Centre for the Democratic Control of Armed Forces. He completed the Course on Disarmament, Demobilization and Reintegration at the Folke Bernadotte Academy in Stockholm, Sweden.
