**PRESENT:** Chairman Gunnells, Vice Chairman Simpson, Councilman Davis, Councilman Calhoun, Councilman Thomas and Councilman Norris.

**CALL TO ORDER:**

Chairman Gunnells called the meeting to order at 7:30 p.m.

**PLEDGE OF ALLEGIANCE:**

Chairman Gunnells led the Pledge of Allegiance.

**INVOCATION:**

Councilman Thomas gave the invocation.

**FREEDOM OF INFORMATION ACT:**

Chairman Gunnells stated for the record that both the Press and Banner and the Index Journal were notified of the meeting and that the meeting was posted on County Buildings as required by the Freedom of Information Act.

**APPROVAL OF MINUTES:**

Councilman Thomas made a motion to approve the minutes of the February 27, 2006, regular county council meeting. Councilman Calhoun seconded the motion. The motion carried 6-0-0.

**PUBLIC COMMENT:**

Mr. Jim Irwin of 625 Highway 20, Abbeville requested an explanation on the amount of the replacement of funds to the Infrastructure Development Millage Special Revenue Fund stipulated in resolution 06-15.

**PRESENTATIONS:** None

## **OLD BUSINESS:**

- a) Third reading of an ordinance (06-03) to lower the property assessment rate on aircraft from 10.5% to 4.0% for Abbeville County. Councilman Davis made a motion to approve third reading. Councilman Calhoun seconded the motion. The motion carried 5-0-1 with Vice Chairman Simpson abstaining.
- b) Third reading of an ordinance (06-04) to amend the Abbeville County Official Zoning Map for a 12.805 acre tract of land located at Willow Point and identified by tax map number 054-00-00-333 from Forest/Agricultural (FA) to General Residential (GR). Vice Chairman Simpson made a motion to approve third reading. Councilman Norris seconded the motion. The motion carried 6-0-0.

## **NEW BUSINESS:**

- a) First Readings: New Policy – All first readings are read into the record by the Chairman, and a vote is not necessary.
- b) Resolutions:
  - 1) A resolution (06-14) authorizing the County Director to advertise a request for proposals from qualified web service providers to design and maintain an Abbeville County web site. Vice Chairman Simpson made a motion to approve the resolution. Councilman Norris seconded the motion. The motion carried 6-0-0.
  - 2) A resolution (06-15) repayment to Infrastructure Development Millage Special Revenue Fund. Councilman Davis made a motion to approve the resolution. Vice Chairman Simpson seconded the motion. The motion carried 6-0-0.
  - 3) A resolution (06-16) authorizing the County Director to enter into a contract with the Upper Savannah Council of Governments to update the Abbeville County Comprehensive Plan of 1999. Councilman Thomas made a motion to approve the resolution. Councilman Calhoun seconded the motion. The motion carried 6-0-0.
  - 4) A resolution (06-17) authorizing the County Director to enter into a contract with Smith Data for the Forms and/or supplies agreement fiscal year July 1, 2006 – June 30, 2007 at a cost not to exceed \$8, 374.78. Councilman Norris made a motion to approve the resolution. Councilman Thomas seconded the motion. The motion carried 6-0-0.
  - 5) A resolution (06-18) authorizing the County Director to enter into a contract with Smith Data for the computer services agreement for

processing charges, software maintenance, and hardware maintenance, printing 2006 vehicles, real & other personal tax and processing delinquent tax notices for fiscal year July 1, 2006 – June 30, 2007 at a cost not to exceed \$94,683.17. Councilman Thomas made a motion to approve the resolution. Councilman Calhoun seconded the motion. Vice Chairman Simpson asked that the resolution be tabled for further study. Councilmen Thomas and Calhoun withdrew their motions. Vice Chairman Simpson made a motion to table the resolution. Councilman Norris seconded the motion. The motion carried 6-0-0.

There being no further items of discussion Councilman Norris made a motion to adjourn. Councilman Thomas seconded the motion. The motion carried 6-0-0.


