M I N U T E S

A CALLED MEETING OF THE ANDERSON COUNTY COUNCIL WAS HELD ON NOVEMBER 10, 1986 AT 4:00 P.M. IN THE ANDERSON COUNTY COUNCIL CHAMBERS - ROOM 109. CHAIRMAN HAROLD E. BEEBE PRESIDED.

Mr. Beebe called the meeting to order and Mr. Watson led with prayer. Everyone stood and pledged allegiance to the flag.

With no objections, the agenda was amended.

Mr. Wiles explained after looking at the Vocational Rehabilitation Center plans, there was a need for moving the sewer lines. 1. It is in the way of grading. 2. Would be necessary to have a pump station if it was not moved to have gravity flow. 3. It would serve the remaining properties. Mr. Wiles moved that this be approved and ask the Sewer Authority to go ahead with the line. Mr. Hooper seconded and vote was 5-0.

The agenda was amended once again.

Mr. Beebe explained that at the last meeting a "Letter of Commitment" had been approved for the County's share of a 50-50 grant for the repaving of a ramp at the Anderson County Airport. Mr. Beebe explained that the funds were needed immediately because of the weather and moved that \$6,000 be transferred from all districts asphalt account into the "0" District for this grant. Mr. Wiles seconded and vote was 5-0.

Mr. Crowe presented the following recommendations for purchasing equipment for road maintenance. He recommended that Council purchase one (1) backhoe from S.C. Tractor Equipment for \$19,849 and is a state contract item. Mr. Wiles moved the approval of the backhoe and Mr. Rhodes seconded. Vote was four (4) in favor and one (1) opposed. Mr. Cox opposed.

Recommend the purchase of one (1) motorgrader (Fiat Allis Model 65-B) from Van Lott for \$49,950. On the motion of Mr. Rhodes, seconded by Mr. Wiles, vote was four (4) in favor and one (1) opposed. Mr. Cox opposed.

Mr. Crowe asked that Council approve a maximum of \$76,000 to purchase either two tandums or one tandem and two single axle trucks on a bid basis. This would allow the purchasing office to order without waiting for another meeting of Council. Council discussed the request and purchasing from local dealerships. Mr. Wiles moved that the \$76,000 be approved to purchase either 2 tandums or one tandem and two single axle trucks on bid as requested. Mr. Hooper seconded and vote was four (4) in favor and one (1) opposed. Mr. Cox opposed. All bid requirements are to be followed.

Mr. Crowe recommended the purchase of two (2) pick up trucks (Dodge 150) off state contract at \$8,099 each. Mr. Wiles moved to approve the request and Mr. Cox seconded. Vote was unanimous.

No citizens wished to speak.

There being no further business, Council adjourned at 4:35 p.m.
