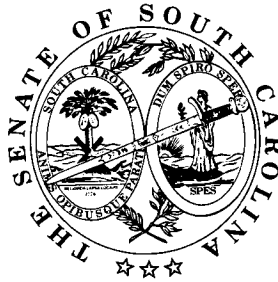

Dear Senator Shealy:

Between the dates of February 11-14, 2014, Temporary employees in South Carolina did not report to work due to accumulations of snow, ice and freezing rain which made the roads extremely hazardous for the general public and making the roads dangerous for Carolinians. South Carolina was declared state of emergency by Governor Nikki Haley.


In ordinary situations, temporary employees already do not get paid for sick days. We will qualify for vacations days if we have accrued at least 1500 hours. We understand this perfectly as it is a part of our agreement as a temporary employee even though we work as hard, or harder than regular full-time employees. As a single woman who owns a home and provides for self, losing 4 days pay was a hard hit to my income. I'm sure a single mom with 2 or 3 children would agree with me. For her, it would be a matter of paying her rent or buying food for her children. Let us not forget she must also pay for child care, even if the child did not attend daycare for those days.

On February 24, 2014, an Executive Order came from Governor Nikki Haley declaring that all state employees absent from work, as directed on February 11, 12, 13 & 14, 2014, due to the closing of state offices caused by hazardous weather conditions were granted leave with pay, while temporary employees lost 4 days pay with no consideration.

At this time I am seeking guidance in receiving information as to who governs temporary agencies to make sure they are taking care of the temporary employees who work and represent them each and every day in the workforce. I know that months have gone by, however, it is also my request that this situation be evaluated, and that temporary employees be given the same consideration as the full time regular employees were, and that we are given back pay for the four days we could not report to work.

Thank you so much for your time and consideration in this matter. I await your response.

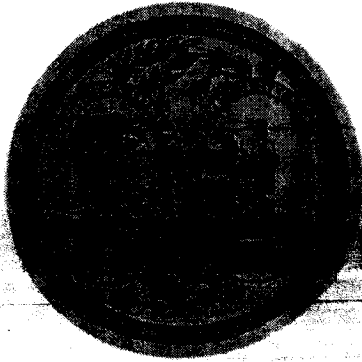

**WHEREAS**, accumulations of snow, ice, and freezing rain for multiple days made road conditions extremely hazardous for the general public, endangering the health, safety, and welfare of South Carolinians; and

**WHEREAS**, because of the dangerous conditions, state government offices were closed as follows: On Tuesday, February 11, 2014, state government offices were closed in Fairfield; closed at 4:00 p.m. in Laurens; closed at 3:30 p.m. in Marion; closed at 3:00 p.m. in Darlington, Newberry, and Spartanburg; closed at 2:30 p.m. in Lee; closed at 2:00 p.m. in Florence; closed at 1:30 p.m. in Chester and Saluda; closed at 1:00 p.m. in Kershaw and McCormick; closed at 12:30 p.m. in Anderson; closed at 12:00 p.m. in Chesterfield, Dillon, and Union; and closed at 11:00 a.m. in Cherokee, Lancaster, and Marlboro. On Wednesday, February 12, 2014, state government offices were delayed until 10:30 a.m. and dismissed at 2:00 p.m. in Horry; delayed until 11:00 a.m. in Georgetown, and closed in the remaining 44 counties with the exception of Beaufort, Colleton, and Jasper. On Thursday, February 13, 2014, state government offices were delayed until 10:30 a.m. in Beaufort and Horry; delayed until 11:00 a.m. in Jasper; delayed until 12:00 p.m. in Williamsburg, and closed in the remaining 43 counties with the exception of Georgetown. On Friday, February 14, 2014, state government offices were delayed until 9:30 a.m. in Marlboro and McCormick; delayed until 10:00 a.m. in Anderson, Clarendon, Greenville, and Greenwood; delayed until 10:30 a.m. in Abbeville, Calhoun, Cherokee, Dillon, and Newberry; delayed until 11:00 a.m. in Kershaw and Orangeburg; delayed until 11:30 a.m. in Chesterfield and Lexington; delayed until 12:00 p.m. in Darlington, Spartanburg, Sumter and Williamsburg; delayed until 1:00 p.m. in Chester; and closed in Aiken, Allendale, Bamberg, Barnwell, Colleton, Dorchester, Edgefield, Fairfield, Florence, Lancaster, Laurens, Lee, Marion, Richland, Saluda, and York.

**NOW, THEREFORE**, pursuant to § 8-11-57 of the South Carolina Code of Laws, all state employees absent from work as directed on February 11, 12, 13, and 14, 2014 due to the closing of state offices caused by hazardous weather conditions are hereby granted leave with pay.

This order shall take effect immediately.

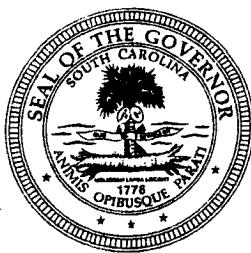

Thank you for contacting the Governor's Office regarding government office closings during winter weather. With regard to this year's winter storms, the Governor issued Executive Orders 2014-09 and 2014-16, which granted leave with pay to state employees whose state offices were closed due to the winter weather. Copies of these Orders can be found at [www.governor.sc.gov](http://www.governor.sc.gov).

Pursuant to Section 8-11-57 of the South Carolina Code of laws, state law only authorizes the Governor to grant leave with pay to state employees, which does not affect state employees who do not accrue leave, such as part-time or temporary state employees. Should you wish to see the law changed, as you indicated in your letter, then we would encourage you to contact your state legislators.
