The regular monthly meeting of the Department of Transportation Commission was held at the offices of the State Department of Transportation in Columbia, South Carolina, at eleven o'clock a.m. on July 15, 1993. SECTION 1: The Minutes for the meeting of June 17, 1993, copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion approving purchase orders issued for amounts in excess of \$10,000.00, during the month of June, 1993, as shown in the Appendix.

SECTION 3: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with the City of North Charleston for the design and construction of a traffic signal system in the City of North Charleston at estimated cost of \$24,000.00 and \$180,000.00, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to enter into an agreement on the US 25 Appalachian Development Project in Greenville County for additional work not included in the original scope of services for the project to include additional surveys, traffic analysis, design and drainage work, as shown in the Appendix.

SECTION 5: The Commission passed a motion authorizing the Department to enter into an agreement with a researcher to conduct an HPR study entitled "Baghouse Fines in Asphalt Mixes" at an estimated cost of \$200,000.00, as shown in the Appendix. Commissioner Harden cast a negative vote no and Commissioner Harvey abstained from voting.

SECTION 6: The Commission unanimously passed a motion authorizing the allocation of transfers and closures of accounts of State Highway funds for capital improvements/land and buildings, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion approving the sale of unserviceable, junked and obsolete property located at the Supply Depot, Shop Road, Columbia, South Carolina, bids for which were received on June 2, 1993, as shown in the Appendix.

SECTION 8: The Commission unanimously passed a motion approving the sale of surplus used motor vehicles and equipment located at the Department's Equipment Depot, Shop Road, Columbia, South Carolina, bids for which were received on June 9, 1993, as shown in the Appendix.

SECTION 9: The Commission unanimously passed a motion approving the sale of surplus used motor vehicles and equipment located at Spartanburg Office, Fairforest Road, Spartanburg, South Carolina and the Laurens Office, Todd Avenue Extension, Laurens, South Carolina bids for which were received on July 7, 1993, as shown in the Appendix.

SECTION 10: The Commission unanimously passed a motion approving the action of the Department in extending existing construction contracts to include additional resurfacing work, as shown in the Appendix.

SECTION 11: The Commission unanimously passed a motion authorizing award of contracts covering resurfacing projects in the July 6, 1993 letting, as shown in the Appendix.

Agreement with the City of North Charleston

The Department requests Commission approval to enter into an agreement with the city of North Charleston for the design and construction of a traffic signal system in the city of North Charleston. Estimated costs for design and construction are \$24,000.00 and \$180,000.00, respectively. That portion on the state highway system is Federal Aid STP funding at 80%, matched by 10% DHPT and 10% city of North Charleston. The City will also contribute basic signalization costs for an intersection not on the state highway system.

US 25 Appalachian Development Project -
Greenville County

It is hereby requested that approval be given to enter into an agreement for additional work not included in the original scope of services for the project. These items include additional surveys, traffic analysis, design and drainage work needed to complete the right of way plans for the project. The funding will be from the Appalachian Development program.

This section of US 25 is currently included in the "GRATS" program as well as the SHIP 10 year program for construction.

Recommendations - 7/15/93

- Research Agreement to conduct an HPR study titled
"Baghouse Fines in Asphalt Mixes"

The Department intends to enter into an agreement with a researcher to conduct an investigation to evaluate the properties of baghouse fines produced at typical SC asphalt plants, to determine the effects of baghouse fines on asphalt mixes, and to establish valid criteria for the reintroduction of baghouse fines into the mix. Included in this study will be laboratory testing to determine the effects of baghouse fines on: (1) the asphalt cement; (2) Marshall mix design characteristics such as stability, VMA, % air voids, density, etc., and (3) rutting potential, durability, moisture susceptibility, and constructability. A final report which contains the results of the laboratory testing and provides recommendations regarding the use of baghouse fines in asphalt pavements will be produced.

It is anticipated that this study will be conducted over a fifteen (15) month period at a cost of \$200,000.00. Highway Planning and Research funds will be utilized to defray the cost of the study.

It is recommended that the Commission give approval for the Department to enter into this agreement.

RECOMMENDATIONS

- 1) Recommend the Department conduct a Procurement Information Outreach Program, designed to increase the number of small businesses participating in all major procurement areas of the program.
- 2) Recommend the Department designate a lead engineer to work with the Department Engineers, Office of Compliance and Supportive Services to ensure positive communication, early technical assistance, quality performance, project site solution and sub-contract mediation for engineering related matters.
- 3) Recommend the Department reactivate the Retired Engineers Assistance Services Program designed to enhance the DBE Prime Contractor's technical knowledge on the construction site through the utilization of engineers with experience in road construction.
- 4) Recommend the Department requires all DBE Firms to complete twenty hours of continuing education annually as required in the State DBE Regulation 63-715, further recommend that all DBE's certified for the first time be required to attend a technical orientation session on the program prior to starting work.
- 5) Recommend the Department implement a Pilot Mentor-Protege Program promoting the partnering concept where a prime contractor may share their experiences and expertise with DBE Contractors on an approved project.
- 6) Recommend the Department implement the required Business Development Program for DBE Contractors including a basic record keeping file for income taxes, administration, operation and job cost etc., further required the DBE to demonstrate a continuing relationship with an account/CPA, bonding agent and banker as requirement for recertification.
- 7) Recommend the Department review all highway related projects to encourage goals including Pre-Construction and professional services areas.
- 8) Recommend the Department appeal to the banking community to participate in developing a Financial Program for improving DBE's Contractors access to capital.

- 9) Recommend the Department explore the feasibility of bonding companies to act as bonding agents for direct contracting, with the department guaranteeing a percentage of the bond.
- 10) Recommend the Department require personal indemnification on Department bonded projects.
- 11) Recommend the Department implement a program when the commission would recognize the Engineer and the DBE firm for outstanding success stories in the field.
- 12) Recommend the Department include cooperation with the DBE's as a part of annual employee evaluation.
- 13) Recommend the Department take step to lay the ground work for conducting a disparity study as required by the courts for state DBE programs.
