Mr. Poore called the meeting to order and Mr. Wright gave the invocation.

On the motion of Mr. Rhodes, seconded by Mr. Gerrard, Council voted unanimously to approve the minutes of the February 6, 1979, meeting as mailed.

Mr. Prue Gilreath, Chairman of the Long Range Planning Committee for the Anderson-Oconee Council on Aging, discussed the need for a Senior Citizens' Park and Multi-Purpose Building. Mr. Gilreath stated that he had discussed the matter with Anderson City Council and he asked County Council to appoint two of its members to a joint committee with the City of Anderson and the Council on Aging to work on the proposed park and activity building. Mrs. Gladys Grantland also discussed the matter and asked Council to appoint two of its members.

Mr. Poore suggested that Council receive the discussion as information. Mr. Poore also recommended that Council authorize him to sell gas and oil to the Council on Aging at the County's cost. On the motion of Mr. Hooper, seconded by Mr. Wiles, Council voted unanimously to sell gas and oil to the Council on Aging at the County's cost.

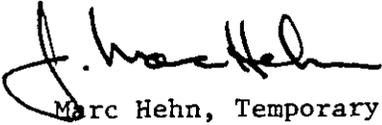
Mr. Bob Lusk discussed the need to amend the Assistance Agreement with Oriental Rugs of Anderson, Inc. (Orlan Rugs). On the motion of Mr. Gerrard, seconded by Mr. Hooper, Council voted unanimously to approve the amended assistance agreement with Oriental Rugs of Anderson, Inc. Mr. Frank Clark discussed the new route for the mall road which the Supervisor had discussed with representatives of the City of Anderson. On the motion of Mr. Hooper, seconded by Mr. Gerrard, Council voted unanimously to adjourn at 10:47 A.M.
