Last year, CVS Health launched a program in collaboration with The Partnership at [Drugfree.org](https://www.drugfree.org) to distribute free drug collection units to local law enforcement agencies. (Press release below.) Thus far only seven communities are participating in the program, including Clinton, Irmo, Barnwell, Easley, Union, Woodruff and Georgetown County. However we have dozens more units that we can distribute. The process to request a drug take back box is relatively simple and involves a short [application](#).
