Senate to vote on Medicare physician payment bill

Thank you to the more than 1,200 advocates who emailed their Senators and many more who called in response to our action alert! Sen. Cardin (D-MD) will be offering an amendment to repeal arbitrary caps on outpatient therapy services, but prospects for passage are unclear. The amendment will not include other provisions that would have strengthened low-income protections and outreach and extended ADRC funding. Passage of the overall bill, which makes permanent the Qualifying Individual (QI) low-income premium protection program, is expected this evening or tomorrow morning.
