

**Re: Notice of Change of Ownership Structure**

Dear Sir or Madam:

I am writing on behalf of our client, Community Health Systems, Inc. (“CHS”). The purpose of this letter is to notify the South Carolina Department of Health and Human Services (“South Carolina Medicaid”) regarding a corporate restructuring by CHS that occurred on December 31, 2007, which affects the parent ownership structures of the various healthcare facilities in South Carolina owned and operated by subsidiaries of CHS, as listed on the attached page (“Facilities”). While the restructuring does not constitute a change of ownership under South Carolina Medicaid laws, we hereby provide the following information and attachments to update the provider files of the Facilities.

As you can see in the attached ownership charts, the restructuring did not result in any changes in the **direct** ownership of the Facilities or the ultimate parent organization, CHS; rather, the restructuring resulted merely in changes to the intermediary parent ownership structure. There has been no change in the tax identification numbers, officers or the day-to-day operations of the Facilities, and there are no other anticipated material changes to the Facilities due to the restructuring. Finally, the restructuring is not considered a change of ownership for Medicare purposes. Accordingly, the restructuring does not result in a change of ownership for South Carolina Medicaid purposes.






