Joyce - In addition to Darryl, the Lt. Governor will be joined by his Chief of Staff Danny Varat. He will also have a security detail but they will not need to be in the meeting.

Here are the hot issues you requested:

HOT issues that are current in South Carolina.

- Legislation pending on moving SUA to new Department of Aging. We want the new department to be

OAA/ACL compliant (We have already asked ACL-Atlanta for guidance when needed).

- New client assessment policy starts on July 1. This eliminates the conflict of the contracted providers assessing, selecting clients, and providing the service. The AAAs will conduct assessments at the regional level and select the clients. SUA has worked closely with ACL Atlanta for guidance in developing new policy.
- SC's senior population is growing significantly and is expected to double by 2030. Our state has serious issues with senior poverty and senior hunger (SC ranks 3rd in the nation with food insecurity for seniors age 60 and over).

Hot issues or area of concern the Lt Governor may want to discuss at the time of **this visit**.

- Does ACL expect budget cuts and how will those cuts affect SC?
- How will the SHIP (State Health Insurance Program) cuts be addressed by ACL and what is the impact to the SC SHIP?
