Hey Katherine,  
I am sorry it took me a while to get back with you. I started writing a long lengthy explanation of the run of the show when a parent said he taped it for us, so I included a link to view all the scenes. This was a tech dress in front of our school. It is just the scenes. And much improvements have been made. It should give you a better visual.

And now for the run of the show. It last an hour. I have 28 students in the show. This show is an original production. When we perform the show we want the audience to walk away with the tools needed to stand against bullying, to encourage bystanders to speak up, and to tell victims it will get better.

Now for the outline of the show...

- ☐ The house opens to inspirational preshow music and the cast meets and greets the audience as they come in.
- ☐ The cast sits with the audience, and I give an introduction to our show. I explain the setting, introduce the tools (to speak up, walk away, be a friend, tell an adult) Then we "get the party started" by bringing the cast up to the stage by singing ¼ of the song "What makes you Beautiful."
- ☐ Once the cast is on stage we discuss the 4 types bullying: verbal, physical, cyber, and social by acting out



examples of each one. This is very important to the show because the audience will see each example again in other scenes.

- I dismiss the cast to behind the set to get ready for the scenes. Then I discuss with the audience Cyber bullying and kids who reach out for help through YouTube for help. In our first scene titled “Why” there are 3 pairs. They are all holding the same signs. ( There are 6 total for better visuals for the audience.) They come out among the audience and as the song starts they get ready to make a YouTube video about bullying. One student ends his scene and walks away making you think he is about to go off and do something drastic while the other student stays and finishes the song vowing to stand up against bullying.
- Then we talk about name calling. We discuss how name calling can hurt worse than a knife and those wounds are hard to heal. Then we talk about what to do if someone call you a name. (speak up, walk away) name calling can hurt if you believe what they are saying is true. This leads up to our next scene “ I Am Me.” This scene is about a girl who gets picked on by bullies but she refused to believe them and the labels fall right off of her. As for her friends they are labeled and the wear their labels until they realize if they do not believe them they will not stick.
- The next scene is titled “Everything”. It is our most powerful scene. We show the battle of the mind when someone is bullied. It is about a girl who forgets what her mom has taught her, and when she goes to school people pick on her severely. The audience sees the good and bad thoughts. The bad thoughts try to get her to kill herself. The good and bad fight for her and the good thought wins. She does not commit suicide. Instead she remembers what her mom tells her.
- After this scene, we discuss the tools again; to speak up, walk away, be a friend and tell an adult. Our next scene is about the bystander. If we are going to fight against bullying we need for the kids who “see” the bullying to tell adults or to help the victim. To change the situation we must start with ourselves.
- This leads to the scene titled “ Man in the Mirror. “ In this scene we see a bystander who witness all types of bullying and he is afraid to do anything until someone he cares about is getting hurt. We show girls fighting over a guy, social bullying, peer pressure and verbal bullying. Once he stands up to the bully the scene stops then goes in reverse. The bullying scenes are retold. This time every situation is solved before any one is bullied.
- Our final scene is titled “Wavin Flag”. We discuss how be different is a blessing not a curse. We talk to the victims in and tell them they can stand up to bullying they need to be brave and never give up. It will get better. They need to wave their flag of courage. For this scene, in order to show being different is a blessing not a curse the costumes were made out of duct tape.
- In this final scene you see 4 scenes where kids are bullied. They become afraid. A bystander give them a flag with an encouraging thought. They wave the flag, and then they go back into the scene and stand up to the bully. In the end everyone is wave a flag of encouragement.
- We end the show with the cast coming together and telling the audience “ When you see something say something”

I hope you can follow my explanation. I know it is really wordy. I promise you will really enjoy it. We really work the crowd. They are not just sitting there for an hour. We make them get involved. We can adjust it for an audience full of adults or an audience of kids. This play is geared for 5-12 grade. We have performed this show 9 times already with 2 more shoe this week. We are performing it at a peace convention in Baltimore Maryland in May.

Again the show is an hour. Please take a moment and check out our tech rehearsal link, and of course call or email me if you have any questions. Most importantly....I want to thank you so much for help us with this performance. This is a dynamic opportunity for our message.
