I would like to know why I'm being placed in lock-up? I was the victim in this riot, I was NOT involved in any way.

ON JULY the 8th 2014⁸ The Ashley unit AT Lieber C.I. was TOOK over due TO the STAFF NOT doing there jobs properly.

Due TO this neglect, I was hit in the head 4-Times by a homemade axe, and stabbed 4-Times. Due TO the Axe assault, I recieved Stitches on the left side of my head, and Stitches on the right side of my Face, A shattered nose, which took surgery to repair it so I could breath, also staples in the back of my head. I Have lost partial eye sight in my left eye. I was rushed to the Emergency room and Treated for these Injuries.

IT TOOK from July 8th until ~~month~~ October 31st for me to be transfered with my life in danger being around the same people that beat me almost to death. Approx - Two weeks later The whole Ashley dorm is Transfered TO the same prison I was transfered TO, again my life is in more danger. I requested state wide protective custody because I signed statements and pointed out inmates that did this

To me, Now most of them are here at Broad river C.I with me again. I'm trying to prevent a law suit against the Dept of corrections, but I see my life means nothing to you people. I respectfully request the following. Either State wide Protective Custody or give me my (MI-3) And place me (on the yard) AT Perry C.I. And leave me alone. I have changed for the better and have stayed out of major trouble.

I was in General Population when your Staff took it into his own hands to open a door he had no write opening. The other 2 - officers have quit there Job due to the staff at liber doing anything they want and getting people hurt.

I see SCDC finally seen the light and moved 90% of that yard. you did it and I no you did it because the Security is that slack.

IF I'm not Transferred to Perry C.I YARD or State wide P.C. I will continue with a law suit. I respectfully deserve this much of a break.

- ④ All of a sudden SCDC finally moves these inmates out of Licker, to a Institution were (I) was transferred for my (so) called Safety.
- ⑤ IT took all these assaults and riots, and these guys taking over this yard (before) SCDC finally realized its the prison officials, NOT the prison.

* All I'm asking for is what I had prior to being almost killed by SCDC's neglect. Licker, C.I Staff are the reason I'm scared for life and was beat and robbed and almost killed.

Send me to Kirkland yard, or Perry yard with my (ME) and Ill sign anything you want I won't file a law suit, which we all know

This is in response to your letter to Protection & Advocacy for People with Disabilities, Inc. (P&A), received in our office 09/16/14.

We contacted the SCDC 504 Coordinator on your behalf regarding your request to be placed on Protective Custody, and the opportunity to be transferred to a different facility. In reply, we were advised that you were disapproved for statewide Protective Custody by the State Classification Committee. However, you were approved for an institutional transfer. You will remain in disciplinary detention in the SMU at Lieber CI until appropriate bed space at another facility is available.
