What is important, is what the numbers do not tell us. As we go forward I think it important that we do so with a view that pays attention to what the board needs to efficiently honor its responsibilities. The focus on numbers has to a troubling degree not occasioned us to focus on impacts. This was evident in yesterdays' meeting in the discussion on consequences /impacts of cutting basketball and the operation of the Museum. I repeat the suggestion that we find a way to do this in phases as opposed to eviscerating the institution in order to get to a balanced budget. A balanced budget under these circumstances is not a barometer of a healthy institution. A plant to attain institutional health is a much more healthy prescription for recovery.
