UK's Spying Bill Complicates Fate Of Data Transfer Deals

A controversial British surveillance bill that requires telecoms to retain records like user browser history for a full year cleared its final hurdle Tuesday, teeing up an almost certain court battle over the breadth of the act's data retention mandate and throwing another wrench into efforts by the U.K. to hammer out international data transfer deals independent of the European Union.

VoIP Access Fees Face Tough Road Ahead At New FCC

A Federal Communications Commission move that allowed local carriers to collect access fees for sending calls "over the top" of internet service provider equipment, which was rejected by the D.C. Circuit earlier this month, faces dim prospects of renewal under a GOP-led commission, experts say.

Goldman Sachs Alum Gets Trump Nod To Run Treasury

President-elect Donald Trump formally unveiled his plans Wednesday to nominate his campaign finance director and former Goldman Sachs executive Steven Mnuchin as the U.S. treasury secretary, with an eye toward pro-growth policies that Mnuchin promised would give no "absolute tax cut" to the wealthy.

EPA Won't Relax Vehicle Emission Standards for 2022-25

The U.S. Environmental Protection Agency said Wednesday that it won't reduce standards on greenhouse gas emissions for cars and light trucks for the years 2022 to 2025, dealing a blow to manufacturers who said the standards are too tough to meet.

European Commission Floats Climate Policy Overhaul

The European Commission on Wednesday unveiled a sweeping set of climate and energy proposals aimed at cutting carbon dioxide emissions by 40 percent by 2030 and implementing regulatory and market changes for investor certainty and consumer fairness.

States Fight EPA Cross-State Air Pollution Rule Revamp

Five states are challenging the U.S. Environmental Protection Agency's recent incorporation of 2008 national ozone standards into the agency's cross-state air pollution rule, which would require several upwind U.S. states to reduce nitrogen oxide emissions from power plants.
