A regular meeting of County Council of Charleston County was held on the 18<sup>th</sup> day of May, 2010 at 7:00 p.m. in Council Chambers, Second Floor, Lonnie Hamilton, III Public Services Building, at 4045 Bridge View Drive, Charleston, South Carolina.

Present at the meeting were the following members of Council: Teddie E. Pryor, Sr., Chairman, who presided; Colleen Condon; Henry E. Darby; Curtis B. Inabinett; Joe McKeown; A. Victor Rawl; Dickie Schweers; J. Elliott Summey. Paul R. Thurmond was absent

Also present were: Allen O'Neal, County Administrator; County Attorney Joe Dawson; and Dan Pennick, Director of the Zoning/Planning Department.

Rev. Robert Reid gave the invocation. Council Member McKeown led in the pledge to the flag.

The Clerk reported that in compliance with the Freedom of Information Act, notice of meetings and agendas were furnished to all news media and persons requesting notification.

Mr. Summey moved approval of the Minutes of May 4, 2010, seconded by Mr. McKeown, and carried.

The Chairman said that Mr. Darby has to leave early in order to attend a function at the school where he is employed and has requested that item 22 be taken up at this time.

Mr. Pryor moved approval of Committee recommendation of May 11, 2010 and Committee recommendation of May 18, 2010, seconded by Mr. Summey, and carried. Council Members Condon, McKeown and Schweers voted nay.

The reports and recommendations concerning the County Fiscal Year 2010 Budget are as follows:

Budget**

A report was read from the Special Finance Committee under date of May 11, 2010 that it considered the information furnished by Allen O'Neal, County Administrator, and Mack Gile, Chief Budget Officer, regarding the Proposed Fiscal Year 2011 County Budgets, which include the General Fund Budget, the Debt Service Fund Budget, the Internal Service Funds Budget and the Special Revenue Funds Budgets, as well as approval of the FY 2011 to 2015 Capital Improvements Plan, the Debt Management Plan and the Transportation Sales Tax Comprehensive Plan of Expenditures.

That Council:

1. Give approval of the FY 2011 General Fund, Debt Service Fund, Enterprise Funds, Internal Service Funds, and Special Revenue Funds budgets in the amount of \$351,321,444, as presented by the County Administrator.

2. Give approval of the FY 2011 to 2015 Capital Improvements Plan, Debt Management Plan and the Transportation Sales Tax Comprehensive Plan of Expenditures, as presented by the County Administrator.

A report was read from the Special Finance Committee under date May 18, 2010 of it considered the information furnished by Allen O'Neal, County Administrator, and Mack Gile, Chief Budget Officer, regarding the Charleston County Budget and those agencies' budgets that are included in the County Budget Ordinance, namely:

1. Trident Technical College;
2. Awendaw Consolidated Fire District;
3. East Cooper Fire District;
4. Northern Fire District
5. West St. Andrews Fire District.

Committee recommended that Council:

1. Approve the budgets for Trident Technical College; Awendaw Consolidated Fire District; East Cooper Fire District; Northern Fire District and West St. Andrews Fire District.
2. Include those budget in the first, second and third Ordinance readings of the County Fiscal Year 2011 Budget Ordinance.

An Ordinance authorizing a fiscal year 2011 budget for Charleston County was given first reading by title only.

PROVISIONS FOR THE FISCAL AFFAIRS OF SAID COUNTY; AND TO PROVIDE FOR THE ISSUANCE OF TAX ANTICIPATION NOTES IN AN AMOUNT UP TO \$25,000,000 FOR CHARLESTON COUNTY AND UP TO \$200,000 FOR AWENDAW CONSOLIDATED FIRE DISTRICT.

**Public Works  
Week**

A report was read from the Finance Committee under date of May 13, 2010 it considered the information furnished by Allen O'Neal County Administrator, and Jim Neal, Public Works Director, regarding a requested resolution to proclaim May 16-22, 2010 as National Public Works Week in Charleston County in order to recognize the contributions which public works officials make every day to ensure the health, safety, comfort and quality of life of the citizens of Charleston County.

Committee recommended that Council adopt a Resolution proclaiming May 16-22, 2010 as National Public Works Week in Charleston County.

Mr. McKeown moved approval of Committee recommendation, seconded by Mr. Summey, and carried.

The Chairman requested Mr. Jim O'Neal, Director of Public Works to Come forward and accept the Resolution, which was read into the record by the Clerk of Council.

**ZREZ 3-10-7522, 19573 Hwy 78**

A report was read from the Planning/Public Committee under date of May 13, 2010 that it considered the information furnished by Allen O'Neal County Administration, and Dan Pennick, Planning and Zoning Director, regarding a requested zoning change in Case # ZREZ 3-10-7522 from the Neighborhood Commercial (CN) Zoning District to the Community Commercial (CC) District.

Committee recommended that Council not approve the request for change in zoning in Case # ZREZ 3-10-7522.

Mr. Schweers moved approval of Committee recommendation for Disapproval, seconded by Mr. Summey, and carried.

**208 Water Quality Program Development**

A report was read from the Planning/Public Committee under date of May 13, 2010 it considered the information furnished by Allen O'Neal County Administrator, and Jim Neal, Public Works Director, regarding the County's designation as a 208 Management Agency. It was stated that Charleston County has been granted Designated Management Agency status under the Federal Clean Water Act, Section 208 Water Quality Management Program, for all unincorporated areas of Charleston County that are not already served. It was further stated that the County had consulted the three major existing wastewater operators, Charleston Water System, Mount Pleasant Water Works, and North Charleston Sewer District, and that each has indicated their willingness and ability to assist the County in the 208 program implementation process.

Committee recommended that Council authorize staff to:

1. Select one or more technical consultants for a contract for wastewater plan review.
2. Further develop long-term solutions and alternatives for administration of the 208 Wastewater/Water Quality Management Planning Program by using in-house forces only.

3. Develop the necessary ordinance amendments to the Zoning and Land Development Regulations Ordinance to establish a process of administration of the County's 208 Designated Management Agency Program until such time as a long-term 208 Wastewater/Water Quality Management Program is developed.

Mr. McKeown moved approval of Committee recommendation, seconded by Mr. Summey, and carried.

**Water Tanker  
Truck**

A report was read from the Finance Committee under date of May 13, 2010 that it considered the information furnished by Allen O'Neal, County Administrator, and Barrett J. Tolbert, Director of the Procurement Department, regarding sealed bids received for the purchase of one new heavy duty 7000 gallon off road water tanker to be utilized by the Environmental Management Department at the Bee's Ferry Landfill. It was stated that the water tanker is a critical machine to the landfill operation and will enhance the working plan in the monthly inspection by the South Carolina Department of Health and Environmental Control.

Committee recommended that Council authorize award of bid for the purchase of a new heavy duty off road water tanker truck to the lowest responsive and responsible bidder, ASC Construction Equipment, in the amount of \$435,627.63, with the understanding that this equipment will be utilized by the Environmental Management Department at the Bee's Ferry Landfill and was approve in the FY2010 budget.

Mr. McKeown moved approval of Committee recommendation, seconded by Mr. Summey, and carried.

**Trident  
Workforce  
Development  
Board**

A report was read from the Finance Committee under date of May 13, 2010 that it considered the information furnished by Allen O'Neal, County Administrator, and Christine DuRant, Director of Grants Administration regard the Trident Workforce Investment Board (TWIB). It was stated that the TWIB is responsible for developing regional workforce policies to carry out the legislative mandate of the Workforce Investment Act (WIV), with funding from the United States Department of Labor (USDOL). It was shown that Membership of the local board must be selected in accordance with the criteria established under the Workforce Investment Act. It was further shown that an advertisement soliciting applications was published and applications for the two Charleston County public sector/legislatively mandated partner and the four private sector seats requiring Charleston County Council's appointment were received and reviewed by the TWIB. It was stated that all eligible applications for appointment were forwarded to Council for review and appointment by Council.

Committee recommended that Council:

1. Appoint James D. Coles, Area Director, South Carolina Employment Security Commission and Frank Oakley Director, Charleston County Department of Social Services as the Legislatively Mandated Partner Appointees for three year terms ending

2. Appoint Steven Brower, CFO, Carolina Starches; Joe Hill, Division VP of Human Resources, Hospital Corporation of America; and Dottie Karst, President, Charles Foster as Private Sector Appointments for three year terms ending in June, 2013.

3. Appoint James Law, Jr., Sales Manager, Coldwell Banker, as a Private Sector Appointment for a one year unexpired term ending in June, 2011.

Mr. McKeown moved approval of Committee recommendation, seconded by Ms. Condon, and carried.

**Trident One  
Stop Center**

A report was read from the Finance Committee under date of May 13, 2010 that it considered the information furnished by Allen O'Neal, County Administrator, and Dan Chandler, Director of Construction and Design, regard the Trident Workforce Investment Board 's lease of its HUB facility known as the One Stop Career Center, which lease will expire on June 30, 2010. It was stated that the Trident Workforce Investment Board will be transferring the lease to the Berkeley/Charleston/Dorchester Council of Governments, and the Executive Directors of COG and One Stop have indicated that they wanted to continue business as usual during the transition time.

Committee recommended that Council authorize the Chairman of Council to execute a Lease Agreement between the County of Charleston and Northwood's Industrial Properties, LLC for property located at 1930 Hanahan Road, North Charleston, SC, for five years, with the option to renew for two, five year terms beginning on July 1, 2010 for an annual rental amount of Two Hundred Ninety Seven Thousand Five Hundred Fifty Three Dollars and Seventy Seven Cents (\$297,553.77), to be increased by three (3%) per cent per year, and with the understanding that this lease can be cancelled for any reason after the first six months of the initial term by giving 120 days written notice to the Landlord, and with the further understanding that, if approved, the County Administrator or Assignee has the authority to approve the exercise of future options and other matters related thereto.

Mr. Condon moved approval of Committee recommendation, seconded by Mr. Summey, and carried.

**GAB  
Recommendations**

A report was read from the Finance Committee under date of May 13, 2001 that it considered the information furnished by Allen O'Neal, County Administrator, Louise Maybank, Chairperson of the Greenbelt Advisory Board and Cathy Ruff, Director of Greenbelt Programs, regarding recommendation from the Greenbelt Advisory Board. It was stated that in November, 2009, County Council tasked the Greenbelt Advisory Board with evaluating the Greenbelt Program and providing Council with specific recommendations within six months. It was shown that the Greenbelt Advisory Board has held six meeting between January and April, 2010 to review the Comprehensive Greenbelt Program and to develop recommendation for Council.

Committee recommended that Council approve the following:

1. **Updated Greenspace Inventory** – Task Greenbelt Staff to gather current data on Charleston County properties protected by organizations outside the Greenbelt Program in order to calculate the total number of acres currently protected.

2. **Further Funding for Urban Unincorporated Areas** – No change is recommended.

3. **Urban Allocations to Beach Communities** – Allow the beach towns to submit applications to use their urban allocations for allowable minor improvements on land the towns currently own. The improvements would be restricted to those allowed in the Comprehensive Greenbelt Plan: boardwalks, foot bridges, unpaved trails, unpaved roadways and unpaved small parking areas. Also, the beach towns would have to agree to place the land under the same covenants and restrictions as all other lands protected with greenbelt funds. Applications for minor improvements would be limited to the beach towns (Folly Beach, Isle of Palms, Kiawah Island, Seabrook Island and Sullivan's Island).

4. **Amendments to Rural Criteria** – No change is recommended.

5. **Using Additional Tools in Conservation Toolbox** – No change is recommended.

6. **Greenway Corridors Goal** – Restate the Greenway Corridors goal as 200 miles instead of 1,200 acres and use trails developed on properties protected through the Greenbelt Program; bike and pedestrian trails developed through the Roadwise Program; and trails developed through other partnering agencies to assist in meeting this 200 mile goal.

7. **Marketing Campaign** – Task Greenbelt Staff to work with the County's Public Information Staff to create a draft marketing plan/strategy to highlight the properties protected through the Greenbelt Program. Any funding needed for marketing materials will be paid from the Greenbelt Administration Budget. The draft marketing plan/strategy will be presented to the Greenbelt Advisory Board for approval.

8. **Updated Greenspace Inventory** – Task Greenbelt Staff to gather current data on Charleston County properties protected by organizations outside the Greenbelt Program in order to calculate the total number of acres currently protected.

Mr. McKeown moved approval of Committee recommendation, seconded by Mr. Summey, and carried.

Code  
Enforcement  
Officer

A report was read from the Finance Committee under date of May 13, 2010 it considered the information furnished by Allen O'Neal, County Administrator, and Bernard E. Ferrara, Esquire, regarding the Commissioning of Code Enforcement Officers for Charleston County. It was shown that in 1994, Charleston County adopted an Ordinance authorizing the issuance of a uniform Ordinance Summons, which is used to enforce any County Ordinance and these Summons are give out by Charleston County Code Enforcement Officers who are commissioned yearly. It was stated that

County employee, Jim Bunn was inadvertently left off the listing approved for re-appointment on December 31, 2009, and staff is requesting that Jim Bunn be re-appointed as a Code Enforcement Officer for Revenue Collections retroactive to January 1, 2010.

Committee recommended that Council re-appoint and Commission Jim Bunn as a Code Enforcement Officer retroactive to January 1, 2010 through December 31, 2010.

Mr. McKeown moved approval of Committee recommendation, seconded by Mr. Summey, and carried.
