AGENCY NAME: HIGHER EDUCATION

ISSUES TO BE ADDRESSED:

1. Addition of New Positions - The State is already obligated to fund 46 USC Medical School positions formerly funded from federal sources. The requests of colleges and universities would require the state to provide funding for approximately 360 additional new positions (excluding those for Technical and Comprehensive Education) if funding is approved at the full formula level. Please justify.
2. Tuition - Tuition costs at several institutions have risen far above levels prevailing at comparable SREB institutions. Please explore the causes of this trend. Discuss also the relationship between tuition and debt service for institutional bonds. How does the state's handling of this relationship differ from the procedure of other states?
3. The State has agreed to assume \$2.7 million additional funding responsibility for the USC Medical School in 1981-82. Please comment on future anticipated funding requirements for this entity. Are there alternatives, such as a merging of the two medical institutions or reliance on residency programs, which could reduce the cost to the state without reducing quality of anticipated medical service availability and delivery in the future?
4. Over the past three decades, state expenditures for higher education as a percentage of total state expenditures have increased steadily. With the expectation that enrollments are now leveling off and may actually decline in the late 1980's, may we expect to see a stabilization of state expenditures in this area? Please comment on enrollment trends as well as anticipated funding needs for higher education.
5. What would be the benefits of granting autonomy to the 4-year branch campuses of USC? The disadvantages? Similarly, can a valid argument be made that USC's two-year regional institutions are the most cost-effective alternative for delivering higher education to the public? Could we not improve both quality and cost-efficiency by consolidating these into nearby 4-year satellite institutions. Is the Commission considering any master plan which could accomplish such an objective?
6. What alternatives could be considered for the use of college or university campuses for the provision of academic courses currently offered by TEC in communities where both types of institutions exist? What cost savings could be realized?
