HISTORY OF COMMUNICATION:

The Governor met with Kishio Miwa, President, Toray Carbon Fiber of America; Yasuo Ueda, General Manager-South Carolina Project, Toray Carbon Fibers; Les Roberts, Plant Engineer, Toray Carbon Fibers of America in her office on May 1, 2013

She also met with Mr. Nikkaku, Mr. Miwa, Mr. Fujikawa, Mr. Suzui, Mr. Onishi, Mr. Morimoto, Mr. Goto, Mr. Ueda, Mr. Kagao, Mr. Clemmons and Mr. Kondo in Spartanburg at a dinner at the Piedmont Club on October 9, 2013.

COMPANY OVERVIEW: Toray Industries, Inc. (Toray) was founded in Japan in 1926 as a manufacturer of rayon.

FINANCIALS

- Toray had sales of \$17.14 billion for the year ending March 31, 2015.

DESCRIPTION OF BUSINESS

- Toray is engaged in the production of chemicals, plastics, synthetic fibers and textiles. It manufactures carbon fiber composite materials, IT-related products, and life sciences products. The group also provides products and services to the engineering and environment sector.
- The group operates through six business segments: fibers and textiles, plastics and chemicals, IT-related products, environment and engineering, carbon fiber composite materials, and life science. Toray is the world's largest producer of polyacrylonitrile (PAN)-based carbon fiber.
- Toray is the sole-source supplier for toughened carbon fiber prepreg used in structural applications of the Boeing 787 Dreamliner. Toray Composites (America) in Tacoma, Washington, and a Toray plant in Japan, manufacture these materials to Boeing's specifications. Carbon fiber prepreg is a tape-like material composed of carbon fibers embedded in a polymer. Prepreg is layered and hardened by autoclave to form products.
- Toray has a joint venture with Daimler AG to mass produce carbon fiber based auto parts in Germany. Earlier this year, Toray and Daimler Trucks North America built a Freightliner concept truck using carbon fiber.

SOUTH CAROLINA OPERATIONS

- In February 2014, Toray announced its plans to invest \$1 billion to build a manufacturing plant on 400 acres near the intersection of highways 290 and 221 in Moore and create 500 jobs.
- Toray also has a location in Fort Mill - Toray Ultrasuede, that markets ultrasuede® and related

- products. Toray purchased the Ultrasuede® brand name from Springs Industries in 1998 and employs 7 people at the Fort Mill location.

The company employs more than 45,700 people worldwide.
