Mr. Poore called the meeting to order and Mr. Seabourn Rider gave the invocation.

On the motion of Mr. Hooper, seconded by Mr. Gerrard, Council voted unanimously to adopt Emergency Ordinance Number 1.

On the motion of Mr. Rhodes, seconded by Mr. Wright, Council voted unanimously to approve the minutes of the May 1, 1977 meeting as mailed.

Mr. M. L. Cheek requested Council accept a road near Highway 252 into the County System. On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to receive the request as information.

Mr. Poore stated that the Stockade is in need of a new dryer. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to request Mr. Hehn check with several appliance companies concerning a new dryer.

Mr. Jerry Williams requested Council give priority to road repairs in Beaver Creek Sub-division and McGee Road off Highway 81. Mr. Poore stated that he will work on the roads in the near future.

Mr. Kennedy Hood, Vice-Chairman of the Council On Aging, along with Mrs. Gladys Grantland, Executive Director, requested \$18,000 for the 1977-78 fiscal year. Mrs. Grantland stated that the Council On Aging is asking for \$5,000 in additional funds because they plan to serve 25 percent more consumers next year. On the motion of Mr. Wright, seconded by Mr. Gerrard, Council voted unanimously to accept the Anderson-Oconee Council On Aging's Budget request as information.

Mr. Hurley Badders of the Pendleton District Historical and Recreational Commission requested \$30,200 for the 1977-78 fiscal year. On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to accept the Pendleton District Historical and Recreational Commission's Budget request as information.

Mr. William Goldman from the Anderson-Oconee Speech and Hearing Services requested \$10,000 from Council for the 1977-78 fiscal year. He stated that last year Speech and Hearing Services served approximately 268 Anderson County residents. On the motion of Mr. Wright, seconded by Mr. Gerrard, Council voted unanimously to accept the Anderson-Oconee Speech and Hearing Services Budget request as information.

On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to adjourn at 8:15 p.m.
