Hi Dorothy,

Our first refugees from Syria are scheduled to arrive today in the early afternoon. It is husband (Mohammad, 39) and wife (Hajar, 36). They fled Syria in November of 2012, registered at UNHCR as refugees in Jordan in February of 2013. They were referred to USA resettlement program by UNHCR office in Amman. They don't speak English and have primary school education. Both clients will have to have medical follow up within 4-6 weeks of arrival due to medical conditions.

This is a short summary of information that was received on their bio-data sheet.
