Rural jobs recruitment:

- Between 2006 and 2011, 26 percent of jobs recruited were in rural counties, while only 21 percent of the state's total labor force lives in rural counties.
- From 2011 to-date (Haley Administration), 21 percent of jobs recruited were in rural areas.
  - o Total Jobs: Rural – 5,405; Urban – 19,578
  - o Total Capital Investment: Rural - \$731,526,884; Urban - \$6,736,774,424

As you know, manufacturing plays an important role in our state's economy. It will continue to do so for the foreseeable future.

- Laurens County has announced four major manufacturing projects since 2010.
- World-class manufacturers, like BMW and Boeing, have continued to grow their operations in South Carolina. This in turn has led to suppliers of these companies either setting up shop here or expanding current business.
- The economic output of the manufacturing industry in South Carolina in 2011 was over \$26 billion, making up 16% of the state's economy. South Carolina is clearly more dependent on the manufacturing industry, as the United States economy is 12% manufacturing.

Since January 2011, South Carolina has recruited more than \$6.8 billion in capital investment and more than 16,000 jobs in the manufacturing sector.

ZF Transmissions:

- Initially announced on July 22, 2010.
- Capital investment: \$350 million; Jobs: 900
- Company will produce fuel-efficient automatic transmissions for the passenger car and light truck market at the new plant.
- Company announced expansion plans for the plant Sept. 7, 2011
- Expansion added \$80 million in investment and 300 new jobs.

Uniscite:

- Announced on Jan. 31, 2012
- Capital investment: \$70 million; Jobs: 100
- Company will produce plastic films such as those used in packaging food.

Flame Spray:

- Announced on April 19, 2011.
- Capital investment: \$9.2 million; Jobs: 50+
- Company will manufacture thermal spray coating mainly for industrial gas turbine and aircraft components.

**BACKGROUND:**

**Tour Purpose:**

- Show support for ZF's and Lauren County's mutual successes.
- Encourage future (proposed) investments by ZF in Laurens County.

**Project Background:**

- ZF originally committed to \$350 million and 900 jobs and immediately expanded another \$80 million and 300 jobs for a total of **\$430 million and 1200 jobs** by September 2011.
- Possible future projects on Gray Court campus (upwards of 800-1000 jobs); plus ZF wants suppliers in South Carolina
- ZF is in the process of installing and testing all the production equipment it needs to launch full production of 8 and 9 speed transmissions in Laurens

County. Future products and projects (including capacity) will be in competition with China.

- “Lu” Reckmann wants the **Application Engineering facility** (R&D) for these transmissions to be in Gray Court (*Not Michigan*). This facility would test and adapt the transmissions for application in different OEM’s vehicles. The resulting jobs would average \$80,000 /year.
- Such a facility would legitimize Gray Court as a true advanced manufacturing plant, because ZF Gray Court would not have to rely on Michigan or Germany to do their Application Engineering.
- This project may well represent the first domino that would initiate and accelerate future expansions for ZF Gray Court.
- Manufacturing of this nature is a stepping stone to making full engines. ++Auto Cluster++

**ETHICS & ACCOUNTABILITY REFORM for 2013**

**#1 – No Incumbent Exemption for Elections Filings**

- The SC Supreme Court’s recent interpretation of state laws regarding candidate filings of Statement of Economic Interest forms created confusion that resulted in over 200 candidates being removed from primary election ballots – none of whom were incumbents for the office they were seeking.
- Current SC law must be clarified to avoid incumbency protection and promote a democratic election process.

We propose to amend current law to require all candidates for public office – whether incumbent or non-incumbent – to file the same forms for candidacy.

**#2 – Mandatory Conflict of Interest Recusals by Lawyer-Legislators**

- Legislators are influencing the appointment of board members who they appear before on behalf of private clients.
- For example, lawyer-legislators continue to influence the appointment process and vote at the committee levels during the confirmation process for the Workers’ Compensation Commission, DHEC Board, and other quasi-judicial boards.

We propose to expand recusal requirements for legislators appearing before boards on behalf of private clients to limit conflicts of interest and improper influence.

**#3 – One Ethics Commission for all Public Officials**

- The current ethics review process lacks coordination and credibility.
  - Lack of Coordination: Our public integrity oversight agencies do not have a coordinated approach to investigating and prosecuting ethical misconduct.
  - Lack of Credibility: Our legislative ethics committees police themselves and their colleagues – “It’s the fox guarding the hen house.”
- The public deserves an ethics review process that strengthens public integrity and can handle violations of ethics laws fairly and consistently.

Attorney General:

We propose to create a Public Integrity Unit to include all state agencies that have varying responsibilities in investigating and prosecuting ethical misconduct. These agencies include SLED, the Attorney General’s Office (State Grand Jury), Department of Revenue, Office of the Inspector General, and State Ethics Commission.

Governor:

We propose a constitutional amendment to expand the State Ethics Commission’s jurisdiction to include members of the General Assembly and dissolve the legislative

ethics committees.

**#4 – Total Income Disclosures for Elected Officials**

- Elected officials are in positions of power, and if left unchecked, they can make decisions and influence policy for personal financial gain. Income disclosures empower the public to hold their elected officials accountable.
- Current state law does not require elected officials to disclose private sources of income. In fact, South Carolina is only one of four states that do not require private sources of income to be reported (Source: National Conference of State Legislatures).
- We need to strengthen our financial disclosure laws to expose potential conflicts of interest.

We propose to increase the financial disclosure requirements for elected officials.

1. Elected Officials should report all income received by himself, his spouse, and his immediate family members (children and other dependents), to include the source, recipient, amount, and how the income was earned:
  - a. Public – Income received from any government entity, including direct income received from a government contract (This is current law - public income of \$500+).
  - b. Private – Income received from any source, including:
    - i. Lobbyist Principals; and
    - ii. Associated Businesses that contract with any government entity.
  - c. (This proposal is modeled after disclosure requirements in Louisiana, Alaska, and Washington – three states among the strongest in the country for financial disclosures.)
2. Elected Officials should report all fiduciary positions held, whether compensated or uncompensated, to include the name of the entity, title of position, and brief description of duties performed:
  - a. Officer, director, trustee of an organization; and
  - b. Partner, proprietor, representative, employee, or consultant of any corporation, firm, partnership, or other business enterprise, any nonprofit, any labor organization, or any educational or other institution.
  - c. Excludes religious, social, fraternal, or political entities.
  - d. (This disclosure is modeled after the U.S. House filing requirements.)

**#5 – Freedom of Information by All Branches of Government**

- Public information should be freely and equally accessible from all branches of government.
- Arguably, the strongest branch of government – the Legislature – has the

weakest requirements for public records disclosure under our Freedom of Information laws.

- Forty-six states have state FOIA laws that are stronger regarding disclosure of legislative records (Source: National Conference of State Legislatures).

We propose to remove the legislative exemption in the Freedom of Information Act so that the public has access to information from all branches of government.

**This email contains two bills that NH filed as a House member regarding ethics disclosures. The first bill regards government contracts (did not become law), and the second bill regards electronic filing (became law).**

\*\*\*THE FIRST BILL:

NH pre-filed H.4271 in December of 2009 regarding the prohibition of public officials contracting with the state. The bill never passed House Judiciary but would have prevented a public official, his spouse, immediate family, or a business with which he was associated from contracting with the jurisdiction of government he serves. The text of the bill is short and included below.

\*This bill differs from the 2013 proposal in two distinct ways:

1. The 2013 proposal includes all government contracts at any level, whereas H.4271 only applied to contracts with the jurisdiction for which the public official served.
2. H.4271 would have expanded the limitations of entering into government contracts for some public officials, whereas the 2013 proposal seeks to expand the disclosure of all government contracts.

**BACKGROUND:**

### **ETHICS & ACCOUNTABILITY REFORM for 2013**

#### **#1 – No Incumbent Exemption for Elections Filings**

- The SC Supreme Court's recent interpretation of state laws regarding candidate filings of Statement of Economic Interest forms created confusion that resulted in over 200 candidates being removed from primary election ballots – none of whom were incumbents for the office they were seeking.
- Current SC law must be clarified to avoid incumbency protection and promote a democratic election process.

We propose to amend current law to require all candidates for public office – whether incumbent or non-incumbent – to file the same forms for candidacy.

#### **#2 – Mandatory Conflict of Interest Recusals by Lawyer-Legislators**

- Legislators are influencing the appointment of board members who they appear before on behalf of private clients.
- For example, lawyer-legislators continue to influence the appointment process and vote at the committee levels during the confirmation process for the Workers' Compensation Commission, DHEC Board, and other quasi-judicial boards.

We propose to expand recusal requirements for legislators appearing before boards on behalf of private clients to limit conflicts of interest and improper influence.

#### **#3 – One Ethics Commission for all Public Officials**

- The current ethics review process lacks coordination and credibility.
  - Lack of Coordination: Our public integrity oversight agencies do not

have a coordinated approach to investigating and prosecuting ethical misconduct.

- Lack of Credibility: Our legislative ethics committees police themselves and their colleagues – “It’s the fox guarding the hen house.”
- The public deserves an ethics review process that strengthens public integrity and can handle violations of ethics laws fairly and consistently.

Attorney General:

We propose to create a Public Integrity Unit to include all state agencies that have varying responsibilities in investigating and prosecuting ethical misconduct. These agencies include SLED, the Attorney General’s Office (State Grand Jury), Department of Revenue, Office of the Inspector General, and State Ethics Commission.

Governor:

We propose a constitutional amendment to expand the State Ethics Commission’s jurisdiction to include members of the General Assembly and dissolve the legislative ethics committees.

**#4 – Total Income Disclosures for Elected Officials**

- Elected officials are in positions of power, and if left unchecked, they can make decisions and influence policy for personal financial gain. Income disclosures empower the public to hold their elected officials accountable.
- Current state law does not require elected officials to disclose private sources of income. In fact, South Carolina is only one of four states that do not require private sources of income to be reported (Source: National Conference of State Legislatures).
- We need to strengthen our financial disclosure laws to expose potential conflicts of interest.

We propose to increase the financial disclosure requirements for elected officials.

1. Elected Officials should report all income received by himself, his spouse, and his immediate family members (children and other dependents), to include the source, recipient, amount, and how the income was earned:
  - a. Public – Income received from any government entity, including direct income received from a government contract (This is current law - public income of \$500+).
  - b. Private – Income received from any source, including:
    - i. Lobbyist Principals; and
    - ii. Associated Businesses that contract with any government entity.
  - c. (This proposal is modeled after disclosure requirements in Louisiana, Alaska, and Washington – three states among the strongest in the country for financial disclosures.)
2. Elected Officials should report all fiduciary positions held, whether compensated or uncompensated, to include the name of the entity, title of

position, and brief description of duties performed:

- a. Officer, director, trustee of an organization; and
- b. Partner, proprietor, representative, employee, or consultant of any corporation, firm, partnership, or other business enterprise, any nonprofit, any labor organization, or any educational or other institution.
- c. Excludes religious, social, fraternal, or political entities.
- d. (This disclosure is modeled after the U.S. House filing requirements.)

#### **#5 – Freedom of Information by All Branches of Government**

- Public information should be freely and equally accessible from all branches of government.
- Arguably, the strongest branch of government – the Legislature – has the weakest requirements for public records disclosure under our Freedom of Information laws.
- Forty-six states have state FOIA laws that are stronger regarding disclosure of legislative records (Source: National Conference of State Legislatures).

We propose to remove the legislative exemption in the Freedom of Information Act so that the public has access to information from all branches of government.

**This email contains two bills that NH filed as a House member regarding ethics disclosures. The first bill regards government contracts (did not become law), and the second bill regards electronic filing (became law).**

\*\*\*THE FIRST BILL:

NH pre-filed H.4271 in December of 2009 regarding the prohibition of public officials contracting with the state. The bill never passed House Judiciary but would have prevented a public official, his spouse, immediate family, or a business with which he was associated from contracting with the jurisdiction of government he serves. The text of the bill is short and included below.

\*This bill differs from the 2013 proposal in two distinct ways:

1. The 2013 proposal includes all government contracts at any level, whereas H.4271 only applied to contracts with the jurisdiction for which the public official served.
2. H.4271 would have expanded the limitations of entering into government contracts for some public officials, whereas the 2013 proposal seeks to expand the disclosure of all government contracts.

**BACKGROUND:**

### **ETHICS & ACCOUNTABILITY REFORM for 2013**

#### **#1 – No Incumbent Exemption for Elections Filings**

- The SC Supreme Court's recent interpretation of state laws regarding candidate filings of Statement of Economic Interest forms created confusion that resulted in over 200 candidates being removed from primary election ballots – none of whom were incumbents for the office they were seeking.

### **#4 – Total Income Disclosures for Elected Officials**

- Elected officials are in positions of power, and if left unchecked, they can make decisions and influence policy for personal financial gain. Income disclosures empower the public to hold their elected officials accountable.
- Current state law does not require elected officials to disclose private sources of income. In fact, South Carolina is only one of four states that do not require private sources of income to be reported (Source: National Conference of State Legislatures).
- We need to strengthen our financial disclosure laws to expose potential conflicts of interest.

We propose to increase the financial disclosure requirements for elected officials.

1. Elected Officials should report all income received by himself, his spouse, and his immediate family members (children and other dependents), to include the source, recipient, amount, and how the income was earned:
  - a. Public – Income received from any government entity, including direct income received from a government contract (This is current law - public income of \$500+).
  - b. Private – Income received from any source, including:
    - i. Lobbyist Principals; and
    - ii. Associated Businesses that contract with any government entity.
  - c. (This proposal is modeled after disclosure requirements in Louisiana, Alaska, and Washington – three states among the strongest in the country for financial disclosures.)
  
2. Elected Officials should report all fiduciary positions held, whether compensated or uncompensated, to include the name of the entity, title of position, and brief description of duties performed:
  - a. Officer, director, trustee of an organization; and
  - b. Partner, proprietor, representative, employee, or consultant of any corporation, firm, partnership, or other business enterprise, any nonprofit, any labor organization, or any educational or other institution.
  - c. Excludes religious, social, fraternal, or political entities.
  
  - d. (This disclosure is modeled after the U.S. House filing requirements.)

#### **#5 – Freedom of Information by All Branches of Government**

- Public information should be freely and equally accessible from all branches of government.
- Arguably, the strongest branch of government – the Legislature – has the weakest requirements for public records disclosure under our Freedom of Information laws.
- Forty-six states have state FOIA laws that are stronger regarding disclosure of legislative records (Source: National Conference of State Legislatures).

We propose to remove the legislative exemption in the Freedom of Information Act so that the public has access to information from all branches of government.

**This email contains two bills that NH filed as a House member regarding ethics disclosures. The first bill regards government contracts (did not become law), and the second bill regards electronic filing (became law).**

\*\*\*THE FIRST BILL:

NH pre-filed H.4271 in December of 2009 regarding the prohibition of public officials

contracting with the state. The bill never passed House Judiciary but would have prevented a public official, his spouse, immediate family, or a business with which he was associated from contracting with the jurisdiction of government he serves. The text of the bill is short and included below.

\*This bill differs from the 2013 proposal in two distinct ways:

1. The 2013 proposal includes all government contracts at any level, whereas H.4271 only applied to contracts with the jurisdiction for which the public official served.
2. H.4271 would have expanded the limitations of entering into government contracts for some public officials, whereas the 2013 proposal seeks to expand the disclosure of all government contracts.

  - c. (This proposal is modeled after disclosure requirements in Louisiana, Alaska, and Washington – three states among the strongest in the country for financial disclosures.)
2. Elected Officials should report all fiduciary positions held, whether compensated or uncompensated, to include the name of the entity, title of position, and brief description of duties performed:
  - a. Officer, director, trustee of an organization; and
  - b. Partner, proprietor, representative, employee, or consultant of any corporation, firm, partnership, or other business enterprise, any nonprofit, any labor organization, or any educational or other institution.
  - c. Excludes religious, social, fraternal, or political entities.
  - d. (This disclosure is modeled after the U.S. House filing requirements.)

#### **#5 – Freedom of Information by All Branches of Government**

- Public information should be freely and equally accessible from all branches of government.
- Arguably, the strongest branch of government – the Legislature – has the

weakest requirements for public records disclosure under our Freedom of Information laws.

- Forty-six states have state FOIA laws that are stronger regarding disclosure of legislative records (Source: National Conference of State Legislatures).

We propose to remove the legislative exemption in the Freedom of Information Act so that the public has access to information from all branches of government.

**This email contains two bills that NH filed as a House member regarding ethics disclosures. The first bill regards government contracts (did not become law), and the second bill regards electronic filing (became law).**

\*\*\*THE FIRST BILL:

NH pre-filed H.4271 in December of 2009 regarding the prohibition of public officials contracting with the state. The bill never passed House Judiciary but would have prevented a public official, his spouse, immediate family, or a business with which he was associated from contracting with the jurisdiction of government he serves. The text of the bill is short and included below.

\*This bill differs from the 2013 proposal in two distinct ways:

1. The 2013 proposal includes all government contracts at any level, whereas H.4271 only applied to contracts with the jurisdiction for which the public official served.
2. H.4271 would have expanded the limitations of entering into government contracts for some public officials, whereas the 2013 proposal seeks to expand the disclosure of all government contracts.

Be it enacted by the General Assembly of the State of South Carolina:

SECTION 1. This act is known and may be cited as the "South Carolina Accountability in Government Act of 2010".

SECTION 2. Article 7, Chapter 13, Title 8 of the 1976 Code is amended by adding:

"Section 8-13-776. (A) On the effective date of this section, no state or local public official, or his spouse, children, members of his immediate family, or any business or entity with which they are associated, may enter into a contract to provide goods or services to the state or local jurisdiction of which he is a public official, whether or not he as a public official has a direct role in preparing the contract as provided in Section 8-13-775.

(B) Any contract for a stated term entered into prior to the effective date of this section which would otherwise be prohibited by the provisions of this section nevertheless remains valid until the expiration of its stated term."

SECTION 3. Article 11, Chapter 13, Title 8 of the 1976 Code is amended by adding:

"Section 8-13-1121. (A) Beginning with the 2010 statements of economic interest filed by members of the General Assembly, the due date for filing is the tenth day of

January, and must reflect all transactions required to be reported which occurred in the previous calendar year.

(B) Beginning with the 2010 statements of economic interest filed by members of the General Assembly, all sources of earned income also must be reported whether or not derived from public or private sources, and if the member receives fee or retainer income for professional services rendered including from those occupations requiring licensure by the State of South Carolina, this fee or retainer income must be separately itemized by client name and amount."

SECTION 4. This act takes effect upon approval by the Governor.

These disclosures and reports must be filed using an Internet-based filing system as prescribed by the commission. Reports and disclosures filed with the Ethics Committees of the Senate and House of Representatives for legislative offices must be in a format such that these filings can be forwarded to the State Ethics Commission using an Internet-based system. The information contained in the reports and disclosure forms, with the exception of social security numbers, campaign bank account numbers, and tax ID numbers, must be publicly accessible, searchable, and transferable."
