

Enclosed you will find “abandoned” paperwork (PS form 3811 and Registered Mail envelope) by Post Master Venusa Gant, which appears to erroneously “allege” that by un-warranted acts, fraudulently claim authority from this Executor Office to administrate for LARRY ANDREA HILL, Estate. This false claims is hereby Adjourned.

I accept your oath (Addendum 1) and I am more then willing to settle any legitimate claim(s), I would expect that obstruction of mail and fabrications of information (impersonating occupant of Executor Office), would be considered an act of fraud, treason, malfeasance, or at least incompetence from this officer as detailed in the trespasses noted in the attached abandon paperwork as followed:

Attachment 1. Post Master Venusa Gant signs PS Form 3811 (restricted delivery) as occupant of executor office, then send PS Form 3811 to occupant of Executor Office in Postmaster envelope (exhibit A) to evading procedures.

Attachment 2. Post Master Venusa Gant opened the registered mail restricted to executor office, when occupant of executor office call for mail, postal employee return with opened executor letter with content (security instrument) taken out and lay private security instrument on counter next to opened envelope, an evasion of privacy. When asked who opened restricted mail, she (postal employee) wrote note on envelope and initialed.

You will forthwith return and transmit the specific written delegated authority to “represent” that authorization to administrate [act as trustee] the LARRY ANDREA HILL Estate has been warranted, together with a certified copy of your oath for the Office of Post Master General, accompanied by certified copies of your BOND, The Office of Post Master General and a detailed list of “all” other bonds, sureties, indemnification, insurance and Court Registry investment System (CRIS) CUSIP numbers and full-accounting relating in any way to anyone’s personal or professional involvement as referenced above and the arrogated paperwork intrusion upon the LARRY ANDREA HILL, Estate.



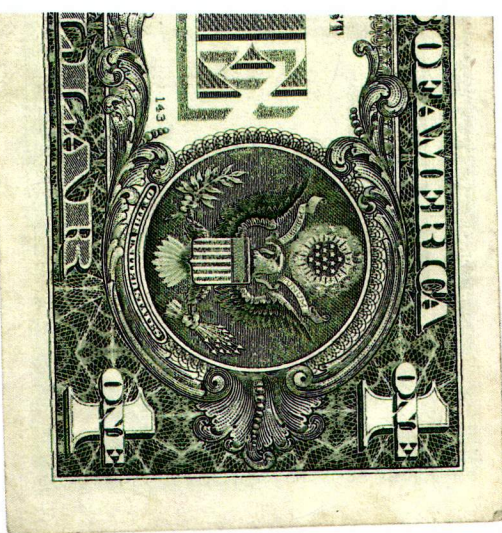
