Hi Rob,

I hope you had a great Christmas. I wanted to reach out to you and the Governor to let you both know Sunrun is planing a ribbon cutting / grand opening ceremony for late this month at our new warehouse off Monticello road in Columbia. Drea Byars is helping me organize and plan this so I've copied her here. Before we set a date, I wanted to extend an invitation to the Governor to cut the ribbon and keynote the event. We are looking at a lunchtime event on either January 20th, 26th, or 27th.

In other states, we usually take our special guests on a tour of the warehouse and have some sort of model solar panel array set up to view. We'll then move to remarks from a few Sunrun officials and introduce our special guest to say a few words before cutting the ribbon.

We will likely invite local and state officials, media, our employees and new customers. Since moving into South Carolina we've surpassed our hiring goals and are up to 80 employees (the original goal was 50 by the end of the year). We've also signed around 500 new customers this year in South Carolina. This was made possible thanks to ACT 236 and Governor Haley's leadership on the issue.
