Holiday Season Donations To One SC Fund Provide Direct Assistance To Flood Victims

November 24, 2015 (Columbia, S.C.) – As the holiday season begins, South Carolinians can provide direct assistance to families and communities devastated by flooding.

Last week, Governor Nikki Haley, working together with the Central Carolina Community Foundation, announced the One SC Fund for flood relief, a fundraising effort that will help South Carolinians who are recovering from unprecedented flooding continue the re-building process.

"We are honored to partner with Governor Haley to assist in flood recovery across our state," says JoAnn Turnquist, President and CEO of Central Carolina Community Foundation. "We are utilizing best practices developed by our colleagues in cities that have experienced similar disasters. Regional Mayors, local funders, board members and civic leaders are being recruited to serve on the grant committee. Our grant process will allow us to identify those nonprofits that have the greatest capacity to help flood victims recover."

How Nonprofits Can Apply for Grants from the One SC Flood Relief Fund

Phase I grants will fund relief and recovery assistance programs provided by nonprofit organizations in the 24 FEMA designated emergency counties. Grants are only available to 501(c)3 organizations and funds are not available for individuals. Nonprofit organizations (or those with a 501c3 fiscal agent) associated with flood relief and recovery may request up to \$25,000. The deadline to submit proposals is Friday, December 4th at 6:00 PM. Applications for Phase II grants will open on December 7th, 2015. Nonprofit can find more information and apply at www.onescfund.org.
