On January 4, 2012, I wrote to inform then Director Keck that my office had reached a settlement with Actavis concerning the reporting of false and inflated AWP's. In my letter, I noted that the payment under the settlement would be made in four installments over the next few years. We recently received the fourth and final installment payment, and the South Carolina Medicaid Program's portion of the settlement is \$199,109.49, consisting solely of "state-share" funds. My finance division will contact your finance division concerning the interagency transfer.

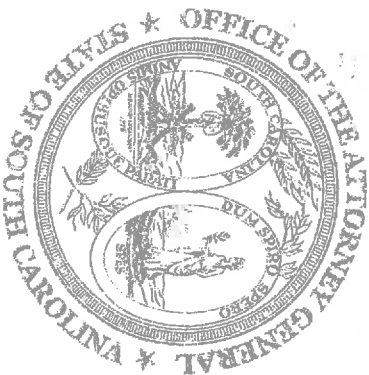
