Dear Senator Graham,

I want to thank you for taking the time to assist with this problem. I have attached the correspondence on this case. But, the Department of Health and Human Services (DHHS) did not answer the main question. Was our house used to receive services provided by Medicaid? If so, why has the person not been charged?

I understand the privacy and rights associated with this personal information and personal health information. But, we as homeowners and taxpayers have rights also. I did not ask them to provide us with any information about the person in question. I want to know if our house was used to commit a crime – fraud. I have attached a copy of the Medicaid coverage information which clearly has our address on it. The person did not live at this address. Also, it is interesting that the Medicaid was approved effective 1 January 2008 and the person was not living in the state at that time. They returned on the 8<sup>th</sup> of January and moved back to Virginia on the 3<sup>rd</sup> of February, then moved back to South Carolina in April 2008.

I first reported this to the DHHS hotline in January 2008. Since then I have received the same answer. They can not release information about the person who the Medicaid was approved for. Again, I did not ask them to release information about her, but whether our house was used illegally. No one will provide us with an answer.

This is government bureaucracy at its worse. The state spent \$469 million on unwed mothers last year and I guess it just does not matter how much more this costs the taxpayers. I provided DHHS with information that a person used our address to obtain benefits and they do not live there, I provided them with a bank routing number and account number where funds are being deposited and the claimant has access to those funds. The claimant did not include this income in their application, but they are still receiving Medicaid benefits. I as a taxpayer am appalled that this is happening and that this welfare Mom and others like her get away with it. They know exactly how to work the system and the hard working people of South Carolina pay for it.

We would appreciate someone contacting the General Counsel, Deirda Singleton, per the attached letter. Ask them to review the case and provide an answer to the question. Was there intent of fraud or was fraud committed using our home? If so, what recourse do we as the homeowner have?

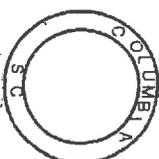

<MSG>Our daughter moved from SC to Virginia on the 4th of November 2007. She returned on the 8th of January 2008. She has no residence in SC.

In January of 2008 I reported potential fraud to DHHS and Berkeley county DSS. My daughter, Julie Anne Myers 33, used our address to obtain Medicaid benefits. The benefits were obtained as an unwed pregnant mother. She does not live with us and at the time had no address in SC. After she was approved for benefits she moved to Virginia on the 3rd of February. She then obtained the same benefits in Virginia. But she stated it was harder to receive the benefits in Virginia because they included the father of the child's income on the applications. Two months later she returned to SC and obtain the benefits again. As she stated it was easier to receive benefits and freebies in SC than in Virginia. She is currently living in the Florenee Crittettton home in Charleston.

The other fact of the matter is she quit a job with potential for over \$40,000 per year in November 2007. She was offered COBRA medical coverage and refused it. She worked for Verizon.

I reported the return to the fraud unit at DHHS and Berkeley county DSS. I also gave them the bank and account number of an out of state bank that she and the father of the child have access to over \$1000.00 Bi-weekly currently. This will increase to over \$1700.00 Bi-weekly in Mid-May. The father of the child is active duty Army and is still married. I informed DHHS that they had changed banks 3 times in 4 months. I also furnished DHHS with his SSN. All of this information was given to me voluntarily by her. I also informed them that we have custody of her 9 year old son and that she should not include him on any benefit requests.

The only answers I have received are no answers. If our house was used for potential fraud then we should be informed. The standard answer is we can not share any information with you.

I read where the state spent \$469 million on unwed mothers last year. If you report fraud and nothing happens I can understand why so much is spent.

I showed DHHS where she will have access to over \$40,000 annually.

I provided them with information on the father of the child.

Why is the father not paying for the medical costs?

Why does not DHHS ask if they have refused any medical coverage, such as COBRA, before they approve the application.

She still is using Medicaid and is walking the streets as a free person.

Why have no charges been filed?

We spent 22 years in the United States Air Force to defend our country. three conflicts, Vietnam, Dessert Storm and Deny Flight. It is a shame that we, as citizens of this nation, try to do the right thing and report fraud and nothing happens. I know it takes time to investigate, but after almost 5 months something should have been done by now. They should both be in jail. Her for fraud. He should be punished under the UCMJ for adultery and fraud.

I now understand why the system is broke and when we become eligible for social program that they will not be able to support us after working for 50 years. What a shame. The folks that need DHHS can't get it and the ones that should not receive there help receive it. It seems as DHHS is not there to assist the folks that contribute to society. They are only there to help Welfare Mom's that drain the system.

Would your office please investigate the matter and provide a response at the earliest possible date.

The use of our address and that the person in question did not even live in South Carolina that was reported in January and February of 2008 was just the start of the intent to commit fraud or the fraud itself. I continued to inform your office of the over \$2000.00 that they had access to per month during the months of March and April that they did not put on their application. I included the bank routing number and the account number. Although, the applicant no longer has access to those funds I am sure they still receive funds under the table. Which if your office would have investigated they would have found this out.

**Your answer as a lawyer to a taxpayer is to retain a lawyer!** My answer to DHHS is **Do your Job!** Protect the taxpayer's money. I will not waste any more of my valuable time with the South Carolina DHHS. You can be assured that Secretary Leavitt and the DHHS/IG Daniel Levinson will receive copies of all the information that I forwarded to your Fraud unit.

This is what I spent 22 years in the Air Force protecting our country for? To be told that I have no protection and that the criminal is protected! I think not.
