According to Dawn Shaw with NASTC, the problem occurs with the coding reported by Michigan DMV. On the citation issued by Michigan police code 2320 (Drive w/o Due Care, Improper Backing) and code 8054 were both listed. Once this was reported to SC, the only applicable code that could be accessed by the SCDMV records department was a code M82 (Inattentive Driving). When these were accessed by the company that quotes rates to NASTC, it fell into the reckless driving category.
