Thank you for writing our agency regarding information on programs in South Carolina that assist incarcerated individuals.

The Department of Health and Human Services administers the Medicaid program that provides health insurance coverage for low-income families and aged, blind or disabled residents of SC. Medicaid eligibility is based on federal and state requirements. To qualify for Medicaid, an individual must meet certain financial and categorical guidelines. A Medicaid eligibility worker can determine if you qualify based on the information provided on an application if you decide to apply. Medicaid coverage is limited to "inpatient services only" for inmates meeting the eligibility criteria for one of our coverage groups. Inpatient services are medical services in an acute care hospital, nursing facility, juvenile psychiatric facility or intermediate care facility.

We have enclosed an overview of the Medicaid program, as well as, a list of state and federal agencies that may be able to assist you.
