Good Afternoon Danny,

We had discussed some language to address Mr. Bailey's issue.

I have three suggestions:

One, the portion in parenthesis indicates where an option in the language:
Amend Section 9-1-1650 by adding "Lump sum payments may be paid before ninety days if the member presents evidence demonstrating an extraordinary and immediate necessity of the funds, such as a family medical crisis, (at the Board's discretion or at the Director's discretion.)"

-With the above option we may have to investigate whether this creates a right that must be given procedural due process.

Two:

Amend Section 9-1-1650 by adding " Lump sum payments may be paid sooner than ninety days where the member can demonstrate a family medical emergency necessitating interstate travel. This need may be shown by a letter from the out of state physician."

-With this option the circumstances are more narrow and we have defined the necessary evidence which likely avoids the need for an appeal process because there is no discretion.

Three:

Amend Section 9-1-1650 by changing the lower bound from ninety days to thirty days or another lower amount.
