Residents of Union County will have the opportunity to meet one-on-one with Gov. Nikki Haley and discuss any issue they want to during constituent meetings Saturday afternoon. The Governor's Office announced Wednesday that Haley will hold a constituent meeting at the City of Union Municipal Building starting at 2 p. m. Saturday. This will be Haley's 20th constituent meeting since becoming governor. Some of her previous constituent meetings have been held in Columbia, Manning, Clarendon, Greenville, Florence, Newberry, Spartanburg, Bennettsville, and Sumter. Saturday will also be Haley's fourth visit to Union since becoming governor.

Matt and Melanie Capobianco waited in a Charleston attorney's office Sunday and thought about what it was like when their role was reversed with the man whose daughter they were trying to adopt. In late 2011, a judge had told the James Island couple to give Veronica to her birth father. The Cherokee Nation member had won custody through the federal Indian Child Welfare Act. The thought of ignoring the decree had crossed their minds. But they questioned themselves. Where would they go? What would their lives be like? Would Veronica recover after the authorities eventually caught up to them?

Despite persistent shear winds, the hurricane season still has a 70 percent chance of being busier than normal, the National Oceanic and Atmospheric Administration predicted today. NOAA scaled back the chance of the most severe hurricanes by one storm, but otherwise held to a prediction of as many as 14 hurricanes, with as many as five having winds of more than 110 mph.

A state lawmaker is proposing that the private Charleston School of Law merge with the College of Charleston to avoid a possible sale. The Post and Courier of Charleston reports (<http://bit.ly/1cxiY>) that Republican Rep. Stephen Goldfinch of Murrells Inlet, a graduate of the law school, is pushing the merger idea. "I believe the Legislature would support such a merger," he said. "It could be done tomorrow." Leaders of the Charleston School of Law, one of two law schools in the state, have entered a management services agreement with InfiLaw Systems which owns three other for-profit law schools.

Years into their attempt to adopt a Cherokee girl, Matt and Melanie Capobianco say they can empathize with any sadness the girl's biological father might be feeling after being ordered to turn her over to them. In late 2011, the Charleston-area couple was in a lawyer's office, tearfully handing over Veronica — whom they'd raised since birth — to the father, Dusten Brown, who lives in Nowata in northeastern Oklahoma.

The Run 2016: In South Carolina, hints of a Dem opening against Hillary

In 2008, if Iowa was the state that cracked Hillary Clinton's inevitability, South Carolina crushed it. The former First Lady was thrashed here in the Democratic primary, getting stomped by nearly 30 points — a demoralizing loss that signaled Barack Obama's popularity was demonstrably wider and deeper than previously perceived. So when I walked into the Trident Technical College auditorium for a state senate Democratic primary debate Tuesday night, I was expecting to encounter a fair share of Obama loyalists. What I wasn't prepared for was the amount of Democrats who appeared to be open to an alternative to Hillary — and even some who openly said her time had passed.

The DOT uses a system to rank interstate upgrades that includes how much traffic a highway is carrying relative to its capacity, the number of accidents and fatalities, truck traffic, pavement condition, financial viability, environmental impacts and economic development. It assigns the greatest weight in the rankings, 30 percent, to the volume of traffic relative to capacity. Next is 20 percent for public safety. The rest of the factors have a weight of 10 percent, Patton said. Several more pieces of the puzzle will have to fall into place before I-526 will get the funding needed to ease its clogged traffic. Next Thursday, the DOT Commission will meet to consider approval of the interstate upgrade priority list presented by agency staff. It will also vote on approval for the 2014-2019 State Transportation Improvement Plan, which includes federal funding for I-526 and the other recommended interstate upgrades.

For the second time in recent months, U.S. District Judge C. Weston Houck is weighing whether issues arising from the acrimonious Episcopal schism in eastern South Carolina belong in federal court. As two bishops sat with their attorneys on either side of his Charleston courtroom, Houck heard about an hour of arguments Thursday on one bishop's request for an injunction against the other. Charles vonRosenberg, the bishop of parishes remaining with the national Episcopal Church, wants the court to block Mark Lawrence, the bishop of churches that left last year, from using the name and the symbols of the Episcopal Diocese of South Carolina.
