

Dear Senator Wilson,

I am writing this letter with a heavy heart and out of sheer desperation. My husband was somewhat diagnosed with Cystic Fibrosis in May of this year. He has been back and forth to the Cystic Fibrosis Clinic at MUSC in Charleston several times a month. He has been in and out of the emergency rooms and doctor's offices numerous times, almost weekly since his diagnosis. He had two sweat tests, one at 48 and one at 50 and they say this is borderline, but that he has all the classic symptoms of the disease. They need the full genetic blood panel to get a 100% diagnosis for the government and to continue his treatment with the Cystic Fibrosis Clinic and for him to be made eligible to receive the assistance with medications. His case is a little rare since he is part Thai and part American and because of this he needs the full testing. The blood test is \$3,000. I spoke with someone at Ambry Genetics, which is the company that administers the test and they agreed to go down to \$500, but even that is ridiculously hard to come by at the present time with our financial situation. This disease is a terminal one. There is no cure and the medicines are just to treat the symptoms and make things less painful. They are doing research all the time and coming closer, but nothing yet. A lung transplant or liver transplant will be in our very foreseeable future and you have to come up with \$86,000 before you can even be put on a waiting list!!

We have only been married 14th months and this has really hit us hard. I am self-employed as a Dance Studio owner in Lexington, Forever Dance, and it's just in it's 3rd year, so it's not making much profit. The business has more overhead than I expected and I'm not clearing that much money. Jason, my husband, has been out of work since February of this year due to how severe his symptoms were. This has been such a hardship and is very frightening to me to have to see this man that I love more than anything, except for my Lord, die before my eyes. We don't have Health Insurance and now can't get any except pretty high premiums and 6 month to 2 year waiting periods for pre-existing conditions. We are racking up thousands in medical bills from doctor's visits, tests, and emergency room visits. He has already had a "near death" experience in the dentist's office while having a tooth pulled! I have called everyone I can call for help with Health Insurance and medication and we can't get Medicaid because I don't meet the poverty level!!!! So this leaves us.....? We are trying to get assistance with medications from different agencies, but have to fill out all kinds of paperwork and wait a month or two for it to process. Then it will be another 3 weeks before we receive the medication. If Jason goes without his medication for 3 months, he will die!!!! He's already been without medication for 1 month now. This is a sad reality and heartbreaking because there's nothing I can do about it.

I have contacted your office but have heard nothing back from you, except that South Carolina has a Health Insurance Risk Pool that will insure the uninsurable but the premium is \$317/month with a \$1500 deductible and a 6 month Pre-Existing Condition waiting period. We can't afford to wait 6 months for him to be treated. He needs to see a Gastroenterologist to have an Endoscopy done because he has been throwing up a lot of blood but they won't even schedule this until we have like thousands to put down.

My faith in God is very strong and I know he has a reason and a purpose for everything, even though I may not understand it. I'm at my wit's end about this situation and have searched above and beyond trying to figure out how to get through this and to keep him alive. I'm truly desperate and feel that contacting you is a last resort. I know

you are extremely busy and have a lot to handle, but if there's anything you can do at all to help us, I would be forever grateful.

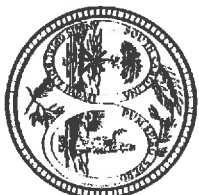
